WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Chand Bibi College of Education for Women, Gulbarga, Karnataka-585104 vide order no. F.KR/Sec/SRO/NCTE/2001-2002/9361 dt. 17.01.2002 for conducting Secondary (B.Ed.) course of one year for the academic session 2000-2001 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students (two basic units of 50 students each) from the academic session 2015-16
- 3. AND WHEREAS, the SRC in its 381st Meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report not accompanied with requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC First Show Cause was issued to the institution on 08.11.2019.
- 4. AND WHEREAS, the SRC in its 402nd Meeting held on 13th& 14th September, 2021 the matter was considered and decided to issued Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice to the institution on 07.10.2021. The institution did not submit any reply to Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 405th Meeting held on 13th& 14th December, 2021 considered the matter and decided to issue Withdrawal order. Accordingly, as per the decision of SRC Withdrawal order was issued to the institution vide order no. F.SRO/NCTE/AOSO0073/B.Ed./{KA}/2021/129846 dated 07.01.2022.
- 6. AND WHEREAS, aggrieved by the SRC withdrawal order, the institution preferred an appeal u/s 18 of NCTE Act before appellate authority. The appellate authority vide order dt. 12.07.2022 has concluded that the SRC was justified in withdrawing the recognition of the appellant institution and therefore the appeal was rejected and the impugned withdrawal order dt. 07.01.2022 issued by the SRC was confirmed.
- 7. AND WHEREAS, the institution filed W.P (C) 11788/2022 titled as Chand BI BI College of Education for Women Versus National Council for Teacher Education & Anr. Before the Hon'ble High Court of Delhi at New Delhi. The Hon'ble High Court vide order dt. 08.08.2022 has directed as under:

- 5. Considering the foregoing, the impugned order of the Appellate Authority dated 12th July, 2022 is quashed. The matter is now remanded back to the Appellate Authority for fresh consideration. Counsel for Petitioner-College states that no additional documents are required to be placed before the Appellate Authority. Accordingly, it is ordered that the Appellate Authority shall take into consideration the documents already placed before them and take a fresh decision thereon, within a period of four weeks from today, in accordance with law. It is therefore, clarified that the Petitioner-College shall be entitled to participate and admit students in respect of the academic session 2022-23. Respondents are directed to update the status of Petitioner-College on their website within a period of one week from today and send intimation in respect thereof to the concerned affiliating university within the same timelines.
- 6. The Court has not examined the merits of the case. All rights and contentions of the parties are left open. The Appellate Authority shall proceed to re-consider in terms of the fore-going directions, uninfluenced by the above observations made by this Court.
- 7. The petition is disposed of in the above terms. The pending application also stands disposed of."
- 8. AND WHEREAS, the SRC in its 413th Meeting held on 22nd& 23rd August, 2022 has considered the order of the Hon'ble High Court and accordingly decided that the institution is entitled to participate in the counselling for the academic session 2022-23 and the withdrawal order issued earlier will be effective from the end of academic session 2022-2023. Accordingly, as per the decision of SRC a letter dt. 05.09.2022 was issued to the institution.
- 9. AND WHEREAS, aggrieved by the SRC order, the institution preferred an appeal u/s 18 of NCTE Act before appellate authority. The appellate authority vide order dt. 21.12.2022 concluded that the SRC was justified in withdrawing recognition of the appellant institution and therefore the appeal was rejected and therefore, the impugned withdrawal order dt. 07.01.2022 issued by the SRC was again confirmed.
- 10. AND WHEREAS, the institution again filed a Writ Petition (C) No. 7782/2023 before the Hon'ble High Court of Delhi. The Hon'ble High Court vide order dt. 02.08.2023 has directed as under:-
 - "20. In view of the aforesaid, this court finds that the case of the petitioner institution requires reconsideration.
 - 21. Accordingly, the following directions are issued:
 - (i) The order passed by the AA dated 21.12.2022 and of the SRC dated 07.01.2022 are hereby set aside.
 - (ii) The recognition of petitioner-institution is restored.
 - (iii) Necessary orders are also to be passed by the NCTE. The petitioner institution is permitted to participate in the counselling and to grant admissions.

- (iv) The matter is remitted back to SRC for fresh consideration. The SRC is directed to conduct a fresh inspection of the petitioner-institution, if necessary, and to issue the proper SCN, pointing out the deficiency, granting sufficient time to the petitioner-institution to submit its reply.
- (v) Depending upon the reply, the SRC would be at liberty to pass appropriate order, a fresh in accordance with law.
- 22. Accordingly, the instant petition stands allowed. Pending application"
- 11. AND WHEREAS, in compliance of the Court order dated 02.08.2023 passed by the Hon'ble High Court of Delhi. The SRC was issued restoration order no. F.SRO/NCTE/AOSO0073/B.Ed./KA/2023/143133-143135 dt. 11.08.2023.
- 12. AND WHEREAS, the SRC in its 428th meeting held on 25th August, 2023 was considered the order dt. 02.08.2023 passed by the Hon'ble High Court of Delhi in W.P. (C) No. 7782 of 2023 and decided as under:-

"....In compliance of Hon'ble High Court of Delhi at New Delhi order dated 02.08.2023 in W.P (C) No. 7782 of 2023 titled as Chand BiBi College of Education for Women Vs. NCTE & Anr., the Committee decided to pass restoration order in favour of petitioner institution i.e., Chand BiBi College of Education for Women, Gulbarga, Karnataka-585104.

Furthermore, the Committee in accordance with the Hon'ble Court's order decided to constitute the online Visiting Team for inspection under section 13 of the NCTE Act, 1993 of the said institute, for examining infrastructural & instructional facilities available."

- 13. AND WHEREAS, as per the above decision of SRC, virtual inspection in u/s 13 was conducted on 08.11.2023 and VT report received on 09.11.2023 was considered by SRC in its 430th Meeting held on 01st December 2023 and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 14.12.2023. The institution has submitted reply of Show Cause Notice vide letter dt. 04.01.2024.
- 14. AND WHEREAS, the SRC in its 431st Meeting held on 10th January, 2024 has considered the matter and decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Chand Bibi College of Education for Women, Survey No. 96/2, Buland Parwaz Colony, Kapnoor Village, Gulbarga, Karnataka-585104 for B.Ed. programme 2 basic units of 50 students each."

- 15. NOW THEREFORE, this order is issued permitting the institution i.e., Chand Bibi College of Education for Women, Survey No. 96/2, Buland Parwaz Colony, Kapnoor Village, Gulbarga, Karnataka-585104 run by Khusro Charitable Trust, Mominpura, Gulbarga, Karnataka for Continuation of recognition for B.Ed. programme of two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 16. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 17. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 18. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 19. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 20. The institution shall make available the list of students admitted on its official website
- 21. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
