AP/M.Ed./SRO/NCTE/2002-2003/80 dated 20.11.2003 for (M.Ed.) Course of one year duration with an annual intake of 25 students from the academic session 2003-2004.

Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 15.07.2023. The institution vide letter dated 26.07.2023 has submitted a reply in response to the Show Cause Notice.
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 15.07.2023. The institution vide letter dated 26.07.2023 has submitted a reply in response to the Show Cause Notice.
- AND WHEREAS, the SRC in its 429th Meeting held on 11th October 2023 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 20.10.2023. The institution has submitted vide letter dated 20.11.2023 reply to Final Show Cause Notice.
- AND WHEREAS, the SRC in its 431st meeting held on 10th January, 2024 considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the St. Mary's College of Education, for P.G. Course, Survey No. 35/part, Ward No. 1, Sarpavaram Village, Kakinada, East Godavari Disrict-533005, Andhra Pradesh for M.Ed. programme for 1 basic unit of 50 students."

- 7. NOW THEREFORE, this order is issued permitting the institution i.e. St. Mary's College of Education, for P.G. Course, Survey No. 35/part, Ward No. 1, Sarpavaram Village, Kakinada, East Godavari Disrict-533005, Andhra Pradesh for continuation of recognition for M.Ed. Programme for two-years duration with an annual intake of (1 basic unit) of 50 students subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **8.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **9.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:

- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
