WHEREAS, the recognition was granted to the institution namely, Good Shepherd College of Education, Holy Cross Road, Nagercoil, Kanyakumari District – 629004, Tamilnadu vide order no. F.TN/SEC/SRO/NCTE/2005-2006/4105 dt. 21.11.2005 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, the SRC in its 216th meeting held on 11th 12th January, 2012 considered the VT report matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.No. APSO3681/B.Ed/TN/2011-12/39037 dated 07.03.2012 was issued to the institution.
- 3. AND WHEREAS, a order vide no. F.No.APSO3681/B.Ed./TN/2011-12/45440 dt. 24.08.2012 permission is hereby accorded by SRC to Good Shephered College of Education, 31/6, 18B, Holy Cross College Road, Nagercoil, Kanyakumari District, Tamilnadu-629004 to shift its premises to the new location/building at Good Shephered College of Education, Holy Cross College Road, Nagercoil, Kanyakumari District, Tamilnadu-629004 restore recognition of the institution.
- **4. AND WHEREAS,** after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution dt. 19.01.2015 and the provisional revised recognition order was issued on 30.04.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- 5. **AND WHEREAS**, on the basis of request of institution, the SRC in its 342nd meeting held on 5th 6th July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, an order was issued to the institution on 20.09.2017 reduction of intake from 2 units to 1 unit.
- **6. AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issue to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued on 03.05.2019. The institution has submitted reply on 23.05.2019.
- 7. **AND WHEREAS**, the SRC in its 386^{th} meeting held on $23^{rd}-24^{th}$ July, 2020 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 05.08.2020. The institution did not submit reply to the Final Show Cause Notice.

8. AND WHEREAS, the SRC in its 401st meeting held on 11st/-12nd August 2021 considered the matter and decided to withdraw the recognition Accordingly as per the

decision of SRC a withdrawal order no. F.SRO/NCTE/APS03681/B.Ed/TN/2021/128502 dated 02.09.2021 was issued to the institution.

AND WHEREAS, the Hon'ble High Court of Madras at Madurai bench bearing W.P. (MD) No.16319/2021 and W.M.P (MD) Nos. 13174 & 13176 of 2021 titled as Good Shepherd College of Education versus National Council for Teacher Education & others. The Hon'ble High Court vide its order dt. 11.01.2023 has directed that: -

"In this view of the matter, the impugned order is quashed. It is however open to the first respondent to pass order on merits after issuing fresh notice to the writ petitioner. With this liberty to the first respondent, this writ petition stands allowed. No costs. Consequently, connected miscellaneous petition is closed."

- 10. AND WHEREAS, a letter has been received on 19.09.2023 from TamilNadu Teachers Education University. The SRC in its 429th meeting held on 11th October, 2023 has considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 20.10.2023. The institution has submitted reply dated 08.01.2024 to Show Cause Notice.
- AND WHEREAS, the SRC in its 431st meeting held on 10th January. 2024 has 11. considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Good Shephered College of Education, Survey No. J.5/27/2, 3 and J.5-25/11,12, Ward No. 24, Holy Cross, College Road, Nagercoil, Koothancadu, Kanyakumari District-629004, Tamilnadu for B.Ed. programme 1 basic unit of 50 students."

- NOW THEREFORE, this order is issued permitting the institution i.e., Good Shephered College of Education, Survey No. J.5/27/2, 3 and J.5-25/11,12, Ward No. 24. Holy Cross, College Road, Nagercoil, Koothancadu, Kanyakumari District-629004, Tamilnadu for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Meservay Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **14.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - Available infrastructural facilities.
 - g. Facilities added during the last guarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **16**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.
- 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself

vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
