**CONTINUATION ORDER**

**WHEREAS**, the recognition was granted to the institution namely, **Yadava College of Education, Yadava College, Thiruppalai, Madurai North Town, Madurai-625014, Tamilnadu** vide SRC (NCTE) order no. F.SRC/NCTE/2009/B.Ed./RO/14771 dt.24.07.2009 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2009-2010.

2. **AND WHEREAS**, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution dt. 23.01.2015 and the provisional revised recognition order was issued on 21.04.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 23.09.2020. The institution has submitted reply on 05.11.2020.

4. **AND WHEREAS**, the SRC in its 399<sup>th</sup> meeting held on 15<sup>th</sup> -16<sup>th</sup> June, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a withdrawal order no. F.SRO/NCTE/APS09666/B.Ed /TN/2021/126956-6963 was issued to the institution on 02.07.2021.

5. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-239/E-195208/2021 Appeal/21<sup>st</sup> Meeting, 2021 Appeal No. APPLSRC202114093 dated 22.10.2021 appeal remand back the order appealed against. The institution has submitted reply on 05.11.2021.

6. **AND WHEREAS**, the SRC in its 404<sup>th</sup> Meeting of SRC held on 16<sup>th</sup> & 17<sup>th</sup> November 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 30.11.2021. The institution has submitted reply on 07.12.2021.

7. **AND WHEREAS**, the SRC in its 412<sup>th</sup> meeting held on 05<sup>th</sup> – 06<sup>th</sup> July, 2022 has considered the matter and decided to issue last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 21.07.2022. The institution has submitted reply on 17.10.2023.

8. **AND WHEREAS**, the SRC in its 430<sup>th</sup> meeting held on 1<sup>st</sup> December, 2023 considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 21.12.2023. The institution has submitted reply on 27.12.2023.

9. **AND WHEREAS**, the SRC in its 431<sup>st</sup> meeting held on 10<sup>th</sup> January, 2024 has considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -*

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Yadava College of Education, Survey No.6/13, 6/17, Thiruppalai, Madurai North Town, Madurai-625014, Tamilnadu for B.Ed. programme for 1 basic unit of 50 students. However the institution is required to appoint the faculty for Fine Arts before start of the academic session."***

**10. NOW THEREFORE,** this order is issued permitting the institution i.e., **Yadava College of Education, Survey No.6/13, 6/17, Thiruppalai, Madurai North Town, Madurai-625014, TamilNadu** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **(1 basic unit) of 50 students** subject to **appointment of the faculty for Fine Arts before start of the academic session** and fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

**11.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

**12.** The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

**13.** The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.



- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.


If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
