WHEREAS, the recognition was granted to the institution namely, Lakshmiammal College of Education, Lakshmiammal Educational Charitable Trust, No.170/1997, Sirunathur Village, Sirunathur Post, Thiruvannamalai 604601, TamilNadu vide SRC order No.F.SRC/NCTE/2009/B.ED/RO/13326 dt. 29.05.2009 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2009-2010.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations notarized affidavit dated 28.04.2014. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue a Final Show Cause Notice in all such matters where the institution has not submitted the documents. Accordingly, a Final Show Cause Notice was issued to the institution on 23.09.2020. The institution vide letter dated 20.10.2020 submitted its reply to the Final Show Cause Notice.
- **4. AND WHEREAS**, the matter was placed before the SRC in its 395th meeting held on 25th 26th February 2021 the committee considered and decided to issue a last reminder letter. Accordingly, a last reminder letter was issued to the institution on 16.03.2021. The institution has submitted reply on 31.03.2021.
- 5. AND WHEREAS, the SRC in its 400th meeting held on July 13th 14th, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Last Reminder Letter. The institution has submitted its reply vide letter dated 31.03.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution was informed that the size of the Multi-purpose Hall is not sufficient (vide Notice dated 16.03.2021). The institution had submitted its reply vide letter dated 31.03.2021 along with the building plan which is not legible, and the Multi-purpose Hall size is shown as 69.6*30 which differs from the size 35.3*30 shown in previously submitted building plan.

- Lecturers namely M.Muniyappam, T.Jegadeesan and R.Dhinagaran are not possessing NET qualification hence not qualified as per NCTE Regulations, 2014 (amended vide notification dated 09.06.2017) as they hence been appointed after 09.06.207.
- 3. Latest Approval letter of faculty issued by the university has not been submitted.

Hence, the Committee decided to withdraw the recognition granted to Lakshmi Ammal College of Education, Sirunathur Village, Thindivanam Road, Tiruvannamalai-Taluk & District, Tamil Nadu-604601 for conducting B.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted Lakshmi Ammal College of Education, Sirunathur Village, Thindivanam Road, Tiruvannamalai-Taluk & District, Tamil Nadu-604601 run by Lakshmi Ammal Educational Charitable Trust, LIG No. 539, TNHB, Thamarai Nagar. Tiruvannamalai-606601, Tamil Nadu for conducting B.Ed. course of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
