ORDER**

WHEREAS, Karuna Teacher Training Institute, Mannengode Post, Pattambi, Palghat District-679307, Kera submitted an application to the Southern Regional Committee of NCTE for grant of recognition for Elementary course of two year duration from the academic session-2004-2005 with annual intake of 50 students and was granted recognition on 02.07.2004 with condition to shift to its own premises/building within three years from the date of recognition (in case the course is started in temporary premises)

AND WHEREAS, the SRC in its 178th meeting held on 13th to 14th July, 2009 the committee considered Shifting premises of the institution and decided to issue show cause notice to the institution. Accordingly a letter was sent to the institution on 27.08.2009 to submit documents regarding shifting of premises. The institution submitted reply on 04.09.2009 & 23.09.2009. another letter was addressed to the institution on 14.10.2009 seeking documents and processing fee of Rs.40,000/-

AND WHEREAS, the institution has submitted a reply on 16.11.2009 along with processing fee of Rs 40,000/-, shifting fee. The institution has stated that they have already shifted to permanent premises.

AND WHEREAS, the institution has submitted written representation on 09.09.2015 regarding Name changing of the Karuna Institute of Teacher Education managed by Karuna Educational and welfare Trust.

AND WHEREAS, the institution has submitted written representation on 16.01.2017 & 09.10.2017 requesting change the name of the institution.

AND WHEREAS, the matter was placed before SRC in its 349th meeting held on 15th to 16th December, 2017 the Committee considered and decided as under as:-

1. They have completed the required formalities.
2. Permit the change of name of the T.T.I

NOW THEREFORE, the permission for change of name is accorded from "Karuna Teacher Training Institute" "Mariyumma Memorial Institute of Teacher Education (MMITE)" subject to no change in the location of institution Structure/Nature of management and other usual conditions.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this Order be published in the Official Gazette.
