AND WHEREAS, the institution has submitted written representation on 09.09.2015 regarding Name changing of the Karuna Institute of Teacher Education managed by Karuna Educational and welfare Trust.

AND WHEREAS, the institution has submitted written representation on 16.01.2017 & 09.10.2017 requesting change the name of the institution.

AND WHEREAS, the matter was placed before SRC in its 349th meeting held on 15th to 16th December, 2017 to Committee considered and decided as under as:-

NOW THEREFORE, the permission for change of name is accorded from "Karuna Teacher Training institute" "Marlyumma Memorial Institute of Teacher Education (MMIYE)" subject to no change in the location of institution Structure/Nature of management and other usual conditions.
