WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Manasa College of Elementary Teacher Education, Kothakota Post, Waraparthy Revenue Division, Mahabubnagar-509381, Mahabubnagar District, Telangana for D.Ed.& D.El.Ed.-Al programme as per following details:-

- (i) Vide Order No.F.SRC/NCTE/D.Ed./2005-2006/2534 dated 26.08.2005 to offer Elementary D.Ed. course of two-years duration with an annual intake of 50 students from the academic session 2005-2006.
- (ii) Vide order No.F.No.SRCAPP903/D.El.Ed.-Al/A.P/2012/46023 dated 11.09.2012 for conducting D.El.Ed. (Additional Intake) course of two-years duration with an annual intake of 50 students from the academic session 2012-2013.
- AND WHEREAS, the SRC in its 413th meeting held on 22nd 23rd August 2022 the Committee discussed in detail about the institutions who failed to submit the PAR as advised by the NCTE. The Regional Director, SRC jurisdictional area and serve a Show Cause Notice for failure of submitting the PAR to all such institutions seeking infrastructural & instructional details along with GIS location etc. If any institution failed to respond to Show Cause Notice for compliance, after completion of given time, the RD, SRC may issue Final Show Cause Notice and place before the Committee for appropriate action. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 08.09.2022.
- AND WHEREAS, a letter dated 13.10.2022 has been received for closure of D.El.Ed. Programme.
- AND WHEREAS, the SRC in its 415th Meeting of SRC held on 3rd 4th November 2022 considered the matter and requesting for closure and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 13.10.2022 by withdrawing the recognition granted to Manasa College of Elementary Teacher Education, Kothakota Post, Waraparthy Revenue Division, Mahabubnagar-509381, Mahabubnagar District, Telangana for conducting D.Ed. & D.Ed-Al Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Manasa College of Elementary Teacher Education, Kothakota Post, Waraparthy Revenue Division, Mahabubnagar-509381, Mahabubnagar District, Telangana run by S.B.N. Education Society, Kothakota Post, Mahabubnagar-509381, Mahabubnagar District, Telangana for conducting D.Ed., D.El.Ed.-A.I. Programme of two years duration with an annual intake of 50 + 50 total 100 students (two units) with effect from the academic session i.e., 2022-2023 onwards.
- **6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
