WHEREAS, the recognition u/s 14 (3) (a) of NCTE Act, 1993 was granted to the institution namely Grace College of Education, Visamangalam Village, Nedungunam Post, Vandavasi Taluk, Thiruvannamalai District — 606807, Tamil Nadu vide Order No. F.TN/SEC/SRO /NCTE/2005-2006/5135 dated 06.01.2006 for conducting (Secondary) B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2005-06.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 02.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and RPRO matter. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 07.05.2019. The institution has submitted reply on 07.06.2019.
- 4. AND WHEREAS, the SRC in its 384th meeting held on 12th 13th February 2020. The Committee considered the matter and decided to issue Final Show Cause Notice to submit the compliance against the conditions mentioned therein. Accordingly, a Final Show Cause Notice was issued on 27.02.2020. the management of the institution has submitted its reply on 21.03.2020.
- 5. AND WHEREAS, the SRC in its 390<sup>th</sup> meeting held on 28<sup>th</sup> October 2020 considered the matter and decided to issue last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 06.11.2020. the institution has submitted its reply on 23.11.2020.
- 6. AND WHEREAS, the SRC in its 402<sup>nd</sup> meeting held on 13<sup>th</sup>-14<sup>th</sup> September 2021 considered the matter and decided to issue withdrawal order. Accordingly, as per decision of SRC a withdrawal order No. F.SRO/NCTE/APS03874/TN/2021/128734 dated 06.10.2021 was issued to the institution.
- 7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. File. No.89-18/E-235820/2022 Appeal/7<sup>th</sup> Meeting, 2022 APPLSRC202114275 dated 19.10.2022 appeal remand back the order appealed against. The institution has submitted reply of Appeal Remand Back Case vide letter dated 24.10.2022.
- 8. AND WHEREAS, the SRC in its 415th meeting held on 03rd & 04th November 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR)."

- NOW THEREFORE, this order is issued permitting the institution i.e. Grace College of NOW THEREFORE, this order is issued permitting the mistigation in the state of the Vandavasi Taluk, Thiruvannamalai District – 606807, Tamil Nadu run by Theresa Educational Trust, Thiruvannamalai District - 606807, Tamil Nadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to the outcome of Writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) and fulfilment of the following conditions:-
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or ١.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE
  - The institution shall make admissions only after it obtains affiliation from the examining body in 11. terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - The institution shall ensure that the required number of academic staff duly approved by affiliating MIL. body for conducting the course should always remain in position. IV.
  - 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
  - 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
  - 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the Particulars of their teaching faculty and non-teaching staff with photographs, for information of all Concerned. The information with regard to the following shall also be made available on the website namely:-
    - Sanctioned programme(s) along with annual intake in the institution: a.
    - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph. b.
    - Name of faculty members who left of joined during the last, quarter:

    - Fee charged from students;
    - Available infrastructural facilities; e. f.

- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
