#### **WITHDRAWAL ORDER**

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Sahithi College of Education, No. 1, 60 Feet Road, Suryapet, Nalgonda District-508213, Telangana run by Sahiti Educational Society, Nalgonda, Telangana vide SRC (NCTE) Order No. F.SRO/NCTE/B.Ed/2007-2008/13892 dated 31.10.2007 for conducting B.Ed. Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 29.01.2015 and the Revised Provisional Recognition Order (RPRO) was issued to the institution for conducting **B.Ed.** programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16 on 06.05.2015.
- 3. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 has considered the matter and the decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a First Show Cause Notice was issued to the institution on 19.11. 2019. The management of the institution has not submitted reply of show cause notice till date.
- **4. AND WHEREAS**, the SRC in its 411<sup>th</sup> meeting held on 23<sup>rd</sup> 24<sup>th</sup> My 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 04.06.2022. The management of the institution has not submitted reply of Final Show Cause Notice till date.
- 5. AND WHEREAS, the SRC in its  $415^{th}$  Meeting of SRC held on  $03^{rd}-04^{th}$  November 2022 considered the matter and non-submission of reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- (i) The institution failed to submit reply to the Final Show Cause Notice dated 04.06.2022.
- (ii) The Committee noted that the institution has not filled Performance
  Appraisal Report (PAR)

Hence the recognition granted to Sahithi College of Education, No. 1, 60Feet Road, Suryapet, Nalgonda District-508213, Telangana for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next

academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn".

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Sahithi College of Education, No. 1, 60 Feet Road, Suryapet, Nalgonda District-508213, Telangana for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two units) with effect from the academic session i.e., 2023-2024 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
