WHEREAS, the institution namely Onkarmal Somani College of Education, Kuvempu Nagar, Mysore, Karnataka-570009 was granted recognition vide SRC (NCTE) order no. F.KAR/B.Ed./62/SRO/NCTE/2000-2001/945 dated 11.07.2000 for B.Ed. course of one year duration from the academic session 2000-2001 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.
- AND WHEREAS, the institution vide letter dated 26.08.2015 submitted application regarding reduction in intake from two basic units to one unit of 50 students. The SRC issued Corrigendum vide Order No.F.SRO/NCTE/AOSO0386/B.Ed/KA/2015/74909 dated 06.10.2015 was issued to the institution for one basic unit. The SRC in its 319th meeting held on 30th-31st August 2016 considered the matter and decided to issue a letter to the institution. Accordingly, a letter was issued to the institution on 03.11.2016. The institution vide letter dated 22.10.2016 & 19.12.2016 submitted the reply of the letter issued to the institution on 03.11.2016.
- AND WHEREAS, the SRC in its 344th meeting held on 17th-18th August 2017 4. considered the matter and decided to the issue order for change of College name. Accordingly, as per the decision of SRC a permission for change college name vide order no. F.SRO/ AOSO0386/B.Ed/KA/2017/94773 dated 11.09.2017 was issued to the institution namely "Onkarmal Somani College of Education, Kuvempu Nagr, Mysore, Karnataka" to "The Institute of Education, Onkarmal Somani College of Education, Kuvempunagar, Mysore, Karnataka-570009".
- AND WHEREAS, the status of issuance of SC/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN in all such cases seeking all the documents in compliance of RPRO matters. Accordingly, a Show Cause Notice was issued to the institution on 04.11.2019. The institution has not submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 08.03.2021. The institution vide letter dated 05.04.2021 submitted reply to the Final Show Cause Notice.

7. AND WHEREAS, the matter was considered by the SRC in its 399th meeting held on 15th & 16th June 2021 decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution The Institute of Education, Site No. P9, Sawkar Channaiah Road, Saraswathipuram, Mysore-570009, Karnataka for B.Ed. programme for 1 basic unit of 50 students."

- 8. NOW THEREFORE, the SRC decided to permit the institution i.e., The Institute of Education, Site No. P9, Sawkar Channaiah Road, Saraswathipuram, Mysore-570009, Karnataka run by Institute of Education Trust, Saraswathipuram, Mysore District, Karnataka-570009 for continuation of recognition for B.Ed. Programme of two-years-duration with an annual intake of (one basic unit) 50 students subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

a. Sanctioned programme(s) along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
