CONTINUATION ORDER

WHEREAS, the institution namely **Gajwel College of Education, Siddipet Revenue Division Pregnapur (V), Gajvel Mandal Medak District, Andhra Pradesh – 502311** was granted recognition vide SRC (NCTE) order no. F.AP/NEW/B.Ed./242/SRO/NCTE/2002-2003/6121 dated 28.02.2003 for **B.Ed.** Course of one year from the academic session 2002-2003 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 08.05.2015 for conducting **B.Ed. course of two years duration** with an annual intake of 100 students for **two basic units** of 50 students each from the academic session 2015-16, subject the condition that to shift the institution to its own premises.

3. **AND WHEREAS**, the institution had applied for shifting premises and the VT was conducted the inspection of Gajwel College of Education, Pamula Parthy Village Medak on 15.10.2016 and inspection report was submitted on 18.10.2016 by VT team.

4. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Show Cause Notice issued on 15.11.2019. The institution submitted vide letter dated 13.12.2019 its reply to the Show Cause Notice.

5. **AND WHEREAS**, the matter was considered by the SRC in its 394th meeting held on January 27th -28th ,2021 and the Committee decided issued to Final Show Cause Notice. Accordingly, Final Show Cause Notice issued to the institution on 04.03.2021. The institution submitted vide letter dated 19.04.2021 its reply to the Final Show Cause Notice.

6. **AND WHEREAS**, the matter was considered by the SRC in its 399th Meeting held on 15th & 16th June 2021 decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee on perusal of the reply submitted by the institution namely **Gajwel College of Education** decided that shifting of premises be permitted to the institution at new address i.e., **Survey No. 743/B, 743/C, 743/C 2, Pamulaparthi Village, Gram Panchayat Wargal Mandal, Medak District-502311, Telangana.***

The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 2 basic units of 50 students each."

7. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Gajwel College of Education, Medak District, Telangana to shift its building at new address at Survey No. 743/B, 743/C, 743/C 2, Pamulaparthi Village, Gram Panchayat Wargal Mandal, Medak District-502311, Telangana** run by **Gajwel Minorities Educational Society, Telangana** Further as per the decision of the SRC, an order for continuation of recognition for B.Ed. Programme of two years duration with an intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
9. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
 12. The institution shall make available the list of students admitted on its official website.
 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
