CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Elim College of Education, Janakipeta Street, Amalapuram East Godavari District-533201, Andhra Pradesh Vide SRC (NCTE) order NoF.AP/NEW/B.ED/256/SRO/NCTE/2002-2003/6119 dated 03.03.2003 for B.Ed. course of one-year from the academic session 2002-2003 with an annual intake of 100 students.

- AND WHEREAS, the SRC vide order no. F.No.APSO0290/B.Ed/AP.2013-14/57394 dated 07.03.2014 the institution was shifted at Elim College of Education, Janakipeta Street, Amalapuram, East Godavari District - 533201, Andhra Pradesh.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 28.01.2015. A revised provisional recognition order (RPRO) was issued to the institution on 26.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016.
- AND WHEREAS, on the basis of request, the SRC in its 342nd meeting decided for reduction of intake from 2 units to 1 unit. Accordingly, a order no. F.No.SRO/NCTE/APSO0290/ B.Ed/AP/2017-18/94297 dated 09.08.2017 was issued to the institution for one basic unit.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Show Cause Notice was issued to the institution on 13.11.2019. The institution submitted its reply to the SCN vide letter dated 28.11.2019.
- AND WHEREAS, the SRC in its 394th meeting held on 27th 28th January, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, the institution was submitted the reply on 24.02.2021.
- 7. AND WHEREAS, the matter was further considered by the SRC in its 399th meeting held on June15th - 16th, 2021 and the Committee decided as follows: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Elim College of Education, Survey No.779/9, 780/1, Ward No-7, Janakipeta Street, Amalapuram, Near Red Bridge, East Godavari District-533201, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students."

- NOW THEREFORE, the SRC decided to permit the institution i.e., Elim College of Education, Survey No.779/9, 780/1, Ward No-7, Janakipeta Street, Amalapuram, Near Red Bridge, East Godavari District-533201, Andhra Pradesh for continuation of recognition for B.Ed. Programme of two years duration with an annual intake of (one basic unit) 50 students subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising 1. loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in 11. the NCTE Regulations, 2014 as amended from time to time.
 - The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & 111. Procedure) Regulations, 2014.
 - The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
 - The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 - The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

a. Sanctioned programme(s) along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c. Name of faculty members who left of joined during the last, quarter:

d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e. Fee charged from students;

f. Available infrastructural facilities;

g. Facilities added during the last quarter;

h. Number of books in the library, journals subscribed to and additions, if any, in the last

The affidavit with enclosure submitted along with application. The institution shall be free to post additional relevant information, if it so desires.

j. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- **12.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
