**CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely, **Mannam Foundation for Teacher Education Technology, Chathakulam, Poruvazhy P.O. Kollam-690520, Kerala** vide SRC (NCTE) order No.F.KL/SEC/N/240/SRO/NCTE/2004-2005/902 dated 25.02.2005 for conducting **Secondary course** of one-year duration with an annual intake of **100** students from the academic session **2004-2005**.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated **24.01.2015**.

3. **AND WHEREAS**, a Revised Provisional Recognition Order (RPRO) was issued to the institution on **29.05.2015** for conducting **B.Ed.** course of two years duration with an annual intake of **50** students (**one basic unit**) from the academic session **2015-2016**.

4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on **17.07.2019**. The institution has not submitted reply to Show Cause Notice till date.

5. **AND WHEREAS**, the matter was further considered by the SRC in its 380<sup>th</sup> meeting held on September 18-19, 2019, and the Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on **31.10.2019** to reply within 21 days. The institution has submitted its reply against Final Show cause on **15.11.2019**.

6. **AND WHEREAS**, the matter was further considered by the SRC in its 389<sup>th</sup> meeting held on October 12 & 14, 2020 and the Committee decided to withdraw recognition granted to Mannam Foundation for Teacher Education Technology, Chathakulam, Poruvazhy P.O. Kollam, Kerala. Accordingly, Withdrawal Order was issued on **19.10.2020**.

7. **AND WHEREAS**, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide order No.89-301/E-172992/2020 Appeal/5<sup>th</sup> Mtg.2021/22<sup>nd</sup> January, 2021 dt. 02.02.2021 remands back the case. The institution has submitted its reply dated **03.02.2021** received on **09.02.2021**.

8. **AND WHEREAS**, the SRC in its 395<sup>th</sup> meeting held on February 25-26, 2021 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC, Final Show Cause Notice was issued to the institution on 10.03.2021. The institution vide letter dated 06.04.2021 submitted reply to the Final Show Cause Notice.



9. **AND WHEREAS**, the matter was further considered by the SRC in its 399<sup>th</sup> meeting held on June 15-16, 2021 and the Committee decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Mannam Foundation for Teacher Education Technology, Survey No.496/2,3,9- 1,93,10,11-2, Ward No. VII Ezammile, Edakkad, P.O. & District Kallam-691552, Kerala for B.Ed. programme for 1 basic unit of 50 students."*

10. **NOW THEREFORE**, the SRC decided to permit the institution i.e., Mannam Foundation for Teacher Education Technology, Survey No. 496/2-2, 496/4-2, 496/3, 496/10, 496/11-2, 496/9-1, 511/11-5, 496/9-3, Ward No. VII Ezammile, Edakkad, P.O. & District Kollam-691552, Kerala run by Mannam Foundation Charitable Society for Rural Education, Thazhathu Chathakulam (PO) Puruvazhy North, Kollam - 691552 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last quarter;
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
15. The institution shall make available the list of students admitted on its official website.
16. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
