WHEREAS, the recognition was granted to the institution namely, Sree Narayana Training College, Sreekandeswaram, Poochakkal P.O. Cherthala-688526, Alappuzha District, Kerala vide SRC (NCTE) order No.F.KL/SEC/N/311/SRO/NCTE/2004-2005/795 dated 23.02.2005 for conducting Secondary course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 13.01.2015.
- 3. AND WHEREAS, a Revised Provisional Recognition Order (RPRO) was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016.
- AND WHEREAS, a Corrigendum was issued to the institution vide Order No. F.SRO/NCTE/APSO1077/B.Ed./KL/2015/77291 on 31.10.2015 for reduction of unit from 2 units to 1 unit.
- AND WHEREAS, the matter was further considered by the Committee in its 388th meeting held on September 14-15, 2020. The Committee decided to issue Show Cause Notice in all such matters where the institution has not submitted the requisite documents. Accordingly, a Show Cause Notice was issued to the institution on 13.10.2020. The institution submitted its reply on 01.12.2020.
- AND WHEREAS, the matter was further considered by the SRC in its 395th meeting held on February 25-26, 2021 and the Committee decided to issue Final Show Cause Notice to the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 08.03.2021 to reply within 21 days for issue of this order. The institution has requested for extension of time for submission of reply vide letter dated 09.04.2021 against Final Show Cause Notice. The institution has submitted its reply on mail dated 14.06.2021.
- **AND WHEREAS**, the matter was further considered by the SRC in its 399th meeting held on June 15-16, 2021 and the Committee decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sree Narayana Training College, Sreekandeswaram, Ward No. 9 Poochakkal P.O. Cherthala-688526, Alappuzha District, Kerala for B.Ed. programme for 1 basic unit of 50 students.

- NOW THEREFORE, the SRC decided to permit the institution i.e., Sree Narayana Training College, Survey No. - 30/22, Sreekandeswaram, Ward No. 9 Poochakkal, P.O. S.N.D.P by Kerala run District. Alappuzha Cherthala-688526, Sreekandeswaram, Poochakkal. P.O Cherthala, Alappuzha, Kerala-688526 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising Ι. loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed in II.

the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & III. Procedure) Regulations, 2014

The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position. IV.

- Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
