AND WHEREAS, the recognition was granted to the institution namely Vivekanandha College of Education for Women, Elayampalayam, Tiruchengodu Taluk, Namakkal District-637205, Tamilnadu vide SRC (NCTE) order no F.SRO/NCTE/B.Ed-Al/2006-2007/47 dated 03.04.2008 for conducting Secondary B.Ed.-A.I. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 22.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 08.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16. - 4. AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September 2020 has considered the matter was considered before the Committee and decided to issue Show Cause Notice to the institution. Accordingly, a Show Cause Notice was issued to the institution on 16.09.2020. The institution vide letter dated 09.10.2020 submitted its reply to the Show Cause Notice.
- 5. **AND WHEREAS**, the SRC in its 395th meeting held during 25th 26th February, 2021 considered the matter and decided to issue Final Show Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 08.03.2021. The institution vide letter dated 15.03.2021 submitted its reply to the Final Show Cause Notice.
- 6. AND WHEREAS, the SRC in its 397th meeting held during 25th & 26th March, 2021 considered the matter and decided to issue a last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 19.04.2021. The institution vide letter dated 11.06.2021 submitted its reply to the last reminder letter.

7. **AND WHEREAS,** the matter was placed before the SRC in its 399th meeting held on 15th – 16th June 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Vivekanandha College of Education for Women, Survey No. 71/1B 72/1B2,3,4 73/3,8B, Elayampalayam Village, Tiruchengodu Taluk, Namakkal District-637205, Tamilnadu for B.Ed., B.Ed.-Al programme for 4 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Vivekanandha College of Education for Women, Survey No. 71/1B 72/1B2,3,4 73/3,8B, Elayampalayam Village, Tiruchengodu Taluk, Namakkal District-637205, Tamilnadu run by Angammal Educational Trust, Elayampalayam-637205, Tiruchengode, Namakkal District, Tamil Nadu for Continuation of recognition for B.Ed. & B.Ed.-A.I. programme for 2 basic units & 2 basic units of 50 students each subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with

photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:

- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
