CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Sri Ganga Parameshwari B.Ed. College, No. 1/1/58, Railway Station Road, Chittapur, Gulbarga District, Karnataka Vide SRC (NCTE) order No. F.SRC/NCTE/B.Ed./2005-2006/5042 dated 30.12.2005 for Secondary B.Ed. course of one-year duration from the academic session 2005-2006 with an annual intake of 100 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 30.01.2015. A revised provisional recognition order (RPRO) was issued to the institution on 18.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 321st meeting held on 28th-30th September 2016 considered the matter and decided that Show Cause Notice issued to the institution. Show Cause Notice issued to the institution on 14.10.2016. The institution did not submitted reply to the Show Cause Notice till date.
- AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 considered the 4. matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, Final Show Cause was issued on 31.08.2020. The institution vide letter dated 24.09.2020 submitted its reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 393rd Meeting held on 05th 36th January 2021 the matter was placed before the Committee and decided to issue Withdrawal order to the institution. Accordingly, as per decision a withdrawal order was issued to the institution vide order no. F.SRC/NCTE/APSO1943/B.Ed./2020/122890-2896 on 11.01.2021.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-89/E-178678/2021 Appeal/12th Mtg.-2021/28th May 2021 dated 02.06.2021 appeal remand back the Order appealed against. The institution prior to Appeal Order vide letter dated 22.1.2021
- AND WHEREAS, the matter was further considered by the SRC in its 399th meeting held on June 15th - 16th, 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Ganga Parameshwari B.Ed. College, Sy. No. 78/4, Mudbool Village Chittapur Taluk, Chittapur, Gulbarga District-585211, Karnataka for B.Ed. programme for 2 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Ganga Parameshwari B.Ed. College, Sy. No. 78/4, Mudbool Village Chittapur Taluk, Chittapur, Gulbarga District-585211, Karnataka for continuation of recognition for B.Ed. Programme for two years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
- e. Fee charged from students;
- f. Available infrastructural facilities;

g. Facilities added during the last quarter;

h. Number of books in the library, journals subscribed to and additions, if any, in the last

The affidavit with enclosure submitted along with application. The institution shall be free to post additional relevant information, if it so desires.

- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display 12. up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 13.
- The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
