WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely NSS Training College, Ottapalam, Palakkad District, Kerala-679101 vide order no. F.KL/Sec/23/SRO/NCTE/1999-2000/5058 dt. 15.03.2000 for conducting B.Ed. (Secondary) course for one year duration from the academic session 2000-2001 with an annual intake of 100.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 300 Students (six basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 320<sup>th</sup> Meeting held during 19<sup>th</sup> & 20<sup>th</sup> September, 2016 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 24.10.2016. The institution has submitted its reply on 21.11.2016.
- 4. AND WHEREAS, the institution has submitted a written representation dt. 09.01.2017 to run two basic units instead of six basic units in compliance with the Government order.
- 5. AND WHEREAS, the SRC in its 388<sup>th</sup> Meeting held on 14<sup>th</sup>-15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the documents/VT report not accompanied with the requisite documents. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 16.04.2021 to B.Ed. and M.Ed. programme. The institution has not submitted any reply to Show Cause Notice.
- 6. AND WHEREAS, the SRC in its 412<sup>th</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> July, 2022 considered the matter and decided to issue Last reminder (letter) to the institution. Accordingly, as per decision of SRC last reminder (Letter) was issued to the institution on 21.07.2022 to B.Ed. and M.Ed. programme. The institution has submitted its reply on 26.08.2022 for B.Ed. programme
- 7. AND WHEREAS, the SRC in its 415<sup>th</sup> Meeting held on 03<sup>rd</sup> & 04<sup>th</sup> November, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution N.S.S. Training College, Ottapalam, Palakkad District, Kerala-679101 for B.Ed. programme, 2 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., N.S.S. Training College, Ottapalam, Palakkad District, Kerala-679101 run by Nair Service Society, Ottapalam, Palakkad District, Kerala-679101 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic unit of 50 students each subject to fulfilment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.

- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
