WHEREAS, the recognition was granted to the institution namely, JRS College of Education, Annamangalam-621102, Veppamtjattai Taluk, Perambalur District, Tamilnadu run by Jesi Educational Society, Annamangalam-621102, Perambalur District, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/4065 dt. 17.11.2005 for conducting Secondary(B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- no.No.APS04146/B.Ed./TN/2011-12/32423 2. AND WHEREAS, an order 17.11.2011 was issued to the institution for shifting premises to the new location/ building at JRS College of Education, Annamangalam-621102, Veeppanthattai Taluk, Perambalur District, TamilNadu.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 27.01.2015 for its willingness of two unit in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, on the basis of request, the SRC in its 343rd meeting held on 01st -02nd July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 12.09.2017 reduction of intake from 2 units to 1 unit.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issue to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on 20.06.2019. The institution has submitted reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 380th meeting considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 04.02.2020. The institution has submitted reply on 25.02.2020.
- AND WHEREAS, the SRC in its 404th Meeting held on 16th & 17th November, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice. The institution has submitted its reply on 25.02.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted notarized copy of land documents instead of certified land documents.
- 2. The institution has submitted notarized copy Non-Encumbrance Certificate which is in regional language.
- 3. The institution has submitted photocopy of Building Plan but not readable.
- 4. The institution has submitted photocopy of Site Plan but not readable.
- 5. The institution has submitted notarized copy of BCC in which date of inspection not mentioned.
- 6. The institution has not submitted copy of "Form A" issued by the respective Bank Manger.
 - (i) As per photocopy of three FDRs submitted by the institution, the FDRs are already expired / matured.
- 7. The institution has not submitted latest faculty list duly approved by Affiliating University.
- 8. The institution has not submitted Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details

Hence, the Committee decided to withdraw the recognition granted to JRS College of Education, Annamangalam-621102, Veppamtjattai Taluk, Perambalur District, Tamilnadu for conducting B.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition JRS College of Education, Annamangalam-621102, Veeppanthattai Taluk, Perambalur District, TamilNadu run by Jesi Educational Society, Annamangalam-621102, Perambalur District, Tamilnadu for conducting B.Ed. programme of two years duration with an annual intake of (1 basic unit) 50 students with effect from the academic session i.e., 2022-2023 onwards.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
