**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely, **Dr. Nagarathinam's College of Education, No. 52/7, Seelanaickanpatti Village, Salem, Tamilnadu-636201** run by **Chandramohan Nagarathinam Educational Trust, Gugai, Salem, Tamilnadu** vide SRC vide order no. F.SRO/NCTE/B.Ed./2006-2007/8993 dt. 08.11.2006 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 292<sup>nd</sup> Meeting held on 29<sup>th</sup> & 30<sup>th</sup> September, 2015 considered the matter decided to permit shifting of the institution. Accordingly, as per decision of SRC vide order no. F.SRO/NCTE/APS04882/B.Ed./TN/2015-16/78232 on 25.11.2015 for permission is hereby accorded to **Dr. Nagarathinam's College of Education, No. 52/7, Seelanaickanpatti Village, Salem, Tamilnadu-636201** to shift its premises to new location/building at **Dr. Nagarathinam's College of Education, 31/1B, Ananthagoundam Palayam, Vennandur (Via), Rasipuram Taluk, Namakkal District, Tamilnadu-637505**.

4. **AND WHEREAS**, on the basis of request, the SRC in its 343<sup>rd</sup> meeting held on 01<sup>st</sup> - 02<sup>nd</sup> July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 12.09.2017 reduction of intake from 2 units to 1 unit.

5. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issue to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on 26.04.2019. The institution has submitted reply on 18.05.2019.

6. **AND WHEREAS**, the SRC in its 400<sup>th</sup> meeting held on 13<sup>th</sup> - 14<sup>th</sup> July, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 02.08.2021. The institution has submitted reply on 18.08.2021.

7. **AND WHEREAS**, the SRC in its 404<sup>th</sup> Meeting held on 16<sup>th</sup> & 17<sup>th</sup> November, 2021 considered the matter and decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

*The institution was issued a Final Show Cause Notice on 02.08.2021. The institution failed to submit reply to the Final Show Cause Notice (FSCN).*

*Hence, the Committee decided to **withdraw the recognition** granted to **Dr. Nagarathinam's College of Education, 31/1B, Ananthagaundam Palayam, Vennandur (Via), Rasipuram Taluk, Namakkal District-637505, TamilNadu** for conducting **B.Ed. programme** with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

8. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Dr. Nagarathinam's College of Education, 31/1B, Ananthagaundam Palayam, Vennandur (Via), Rasipuram Taluk, Namakkal District-637505, TamilNadu** run by **Chandramohan Nagarathinam Educational Trust, Gugai, Salem, Tamilandu** for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2022-2023 onwards.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

***"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."***

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
