WHEREAS, the recognition was granted to the institution namely, Cosmopolitan College of Education, Cosmopolitan Educational Cultural & Social Development Trust, Sengadu P.O., Sriperambathur, Chennai, Kancheepuram — 602002, Tamilnadu run by Cosmopolitan Educational Cultural & social Development Trust, Sengadu Post, Sriperambathur, Kancheepuram, Tamilnadu vide SRC vide order no. F.SRC/NCTE/2009/B.Ed./RO/13639 dt. 03.06.2009 for B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2009-2010.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 23.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 23.03.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> September 2020 considered the matter and decided to issue a Show Cause Notice to all the institutions wherein Recognition was accorded by the SRC under Regulations 2014 with the direction to submit all requisite documents. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution on 02.08.2021. The institution has submitted reply on 08.08.2021.
- 4. **AND WHEREAS**, the SRC in its 402<sup>nd</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> September, 2021 the matter was considered and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 08.10.2021. The institution has submitted reply on 05.10.2021.
- **5. AND WHEREAS,** the SRC in its 404<sup>th</sup> Meeting held on 16<sup>th</sup> & 17<sup>th</sup> November, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 05.10.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution did not submit the latest approval of faculty for B.Ed. and M.Ed. courses issued by the affiliating University.
- 2. The institution did not submit Affidavit of Rs 100/- stamp paper regarding land, building & management.

Hence, the Committee decided to withdraw the recognition granted to Cosmopolitan College of Education, Cosmopolitan Educational Cultural & Social Development Trust, Sengadu P.O., Sriperambathur, Chennai, Kancheepuram – 602002, Tamilnadu for conducting B.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Cosmopolitan College of Education, Cosmopolitan Educational Cultural & Social Development Trust, Sengadu P.O., Sriperambathur, Chennai, Kancheepuram 602002, Tamilnadu run by Cosmopolitan Educational Cultural & social Development Trust, Sengadu Post, Sriperambathur, Kancheepuram, Tamilnadu-602002 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
