WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **ATR College of Education, Khasara no. 155/4B, Plot No. 1, Main Road, Kalasthampadi Village and Post, Thiruvannamalai Taluk, Thiruvannamalai District, Tamilnadu** run by **Sree Balaji Educational & Charitable Trust, Avalur Pet Main Road, Kalasthampadi Village and Post, Thiruvannamalai Taluk, Thiruvannamalai District, Pin-606805, Tamilnadu** vide SRC (NCTE) order F.SRCAPP596/B.Ed./TN/2012/45109 dated 10.08.2012 for conducting **B.Ed. Course** of one-year duration with an annual intake of 100 students from the academic session 2012-2013.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 369<sup>th</sup> Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 30.06.2019. The institution did not submit any reply to Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 380<sup>th</sup> Meeting considered the matter and decided to issue Final Show Cause Notice to the institution to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 25.10.2019. The institution did not submit any reply to Final Show Cause Notice till date.

5. **AND WHEREAS**, the SRC in its 404<sup>th</sup> Meeting held on 16<sup>th</sup> – 17<sup>th</sup> November, 2021 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

*The institution was issued a Final Show Cause Notice on 25.10.2019. The institution failed to submit reply to the Final Show Cause Notice (FSCN).*

*Hence, the Committee decided to withdraw the recognition granted to **ATR College of Education, Khasara no. 155/4B, Plot No. 1, Main Road, Kalasthampadi Village and Post, Thiruvannamalai Taluk, Thiruvannamalai District, Tamilnadu** for conducting **B.Ed. programme** with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

6. **NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **ATR College of Education, Khasara no. 155/4B, Plot No. 1, Main Road, Kalasthampadi Village and Post, Thiruvannamalai Taluk, Thiruvannamalai District, Tamilnadu** for conducting B.Ed. programme of two year duration with an annual intake of 100 students (two basic units) for B.Ed. course with effect from the academic session i.e. 2022-2033 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
