WHEREAS, the recognition was granted to the institution namely, K.L.E. Society's College of Education, Shedgeri, Near Sundaranarayana Temple Road, Ankola, Uttara Kananada District, Karnataka-581314 run by K.L.E Society, Belgaum, Karnataka vide SRC vide order no. F.SRO/NCTE/B.Ed./2004-2005/1254 dated 10.03.2005 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 320^{th} meeting held on $19^{th} 20^{th}$ September, 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause was issued to the institution on 07.11.2016. The institution has not submitted reply to the institution.
- 4. AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per decision taken in its 380th Meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 23.10.2020. The institution has submitted reply on 03.11.2020.
- **5. AND WHEREAS**, the SRC in its 400th meeting held on 13th -14th July, 2021 considered the matter and decided to withdraw the recognition. Accordingly, a withdrawal order issued to the institution vide order No. F.SRO/NCTE/APS02507/B.Ed./KA/2021/127823-7830 dated 29.07.2021.
- 6. AND WHEREAS, the SRC in its 403rd meeting held on 18th 19th October, 2021 considered the matter and decided to issue corrigendum. Accordingly, a corrigendum was issued to the institution order No. F.SRC/NCTE/APS02507/B.Ed./KA/2021 /129124 dated 11.11.2021.
- 7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority ef-the NCTE. The Appellate Authority vide order No. 89-220/E-193133/2021 Appeal/20th Meeting, 2021 APPLSRC202114084 dated 04.10.2021 appeal remand back case. The institution has submitted on 11.10.2021.
- **8. AND WHEREAS**, the SRC in its 404th meeting held on 16th 17th November, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1903, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were

Society's College of Education, Survey No. 85 & 86 Shedgeri, Ankola, Ward No. 8, Shedgeri, Near Sundaranarayana Temple Road, Ankola, Uttara Kananada District, Karnataka-581314 for B.Ed. programme for 2 basic units of 50 students each."

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. K.L.E. Society's College of Education, Survey No. 85 & 86 Shedgeri, Ankola, Ward No. 8, Shedgeri, Near Sundaranarayana Temple Road, Ankola, Uttara Kananada District, Karnataka-581314 run by K.L.E. Society's, Survey No. 85 & 86 Shedgeri, Ankola, Ward No. 8, Shedgeri, Near Sundaranarayana Temple Road, Ankola, Uttara Kananada District, Karnataka-581314 for continuation of recognition for B.Ed. programme for two years-duration with annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time......
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. - i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
