WHEREAS, the recognition was granted to the institution namely, Vickram Teacher Training College, Sreeniyasa Gardens, Madurai Siyagangai Road, Enathi, Siyagangai District, Tamilnadu-630561 vide SRC vide order no. F.TN/SEC/SRO/NCTE/2005-2006/3910 dt, 08.11.2005 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and Committee 3. decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 19.02.2019. The institution has submitted reply on 28.03.2019.
- AND WHEREAS, the SRC in its 379th Meeting held on 21st & 22nd August, 2019 4. considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 02.09.2019. The institution has submitted reply on 28.09.2019.
- AND WHEREAS, the SRC in its 404th Meeting held on 16th & 17th November, 2021 5. considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 28.09.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution did not submit certified copy of the registered land documents.
- The principal is not appointed by the institution.
- The institution has submitted FDRs all were matured.
- The institution submitted a letter dt. 31.01.2018 issued by the Tamilnadu Teachers Education University whereby only 9 faculty have been approved.

The faculty strength is not enough for running B.Ed. course with 2 units and failed in submission of latest approval of faculty issued by the University.

5. According to the Encumbrance Certificate submitted by the institution, the nature of land is Agricultural.

Hence, the Committee decided to withdraw the recognition granted to Vickram Teacher Training College, Sreenivasa Gardens, Madurai Sivagangai Road, Enathi, Sivagangai District, Tamilnadu-630561 for conducting B.Ed. programme with effect from the academic session i.e., 2022-23 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Vickram Teacher Training College, Sreenivasa Gardens, Madurai Sivagangai Road, Enathi, Sivagangai District, Tamilnadu-630561 run by Srinivas Trust, 7 Commanding Officer Second Lane, West Masi Street, Madurai, Tamilnadu-625001 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
