WITHDRAWAL ORDER**

WHEREAS, recognition u/s14 of NCTE Act, 1993 was granted to the institution namely, School of Education VISTAS Vels University, Khasara No. 156/707, Plot No. 31 Off OMR (IT Highway), Thalambur Village & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District-600130, Tamilnadu run by Vels Institute of Science Technology and Advanced Studies, Plot No.9, P.V. Vaithiyalingam Road, Velan Nagar Village, Pallavaram Post Office, Alandur Taluk, Pallavaram Chennai City, Kanchipuram District-600117, Tamilnadu vide SRC (NCTE) order no. F. SRO/NCTE/SRCAPP2313 /B.Sc.B.Ed./TN/2016-2017/85032 dt. 02.05.2016 for conducting B.Sc.B.Ed. programme of Four years duration with an annual intake of 100 students (2 units) from the academic session 2016-2017.

2. AND WHEREAS, the institution vide letter dated 22.06.2022 requested for closure of the institution.

3. AND WHEREAS, the SRC in its 413th Meeting of SRC held on 22nd – 23rd August 2022 considered the and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the B.Sc. B.Ed. programme as requested by the Management vide their letter dated 22.08.2022 by withdrawing the recognition granted to School of Education VISTAS Vels University, Khasara No. 156/707, Plot No. 31 Off OMR (IT Highway), Thalambur Village & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District-600130, Tamilnadu under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".


4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted School of Education VISTAS Vels University, Khasara No. 156/707, Plot No. 31 Off OMR (IT Highway), Thalambur Village & Post Office, Thiruporur Taluk, Chennai City, Kanchipuram District-600130, Tamilnadu run by Vels Institute of Science Technology and Advanced Studies, Plot No.9, P.V. Vaithiyalingam Road, Velan Nagar Village, Pallavaram Post Office, Alandur Taluk, Pallavaram Chennai City, Kanchipuram District-600117, Tamilnadu for conducting B.Sc.B.Ed. Programme of Four years duration with an annual intake of 100 students (2 units) with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
