WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Goutham B.Ed. College, Allipur, Hospet Road, Bellary, Karnataka – 583104 run by Bellary Educational Services Trust, Bellary, Karnataka vide order no. F.SRC/NCTE/B.Ed./2005-2006/5344 dt. 03.02.2006 for conducting Secondary (B.Ed.) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 28.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 18.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 316<sup>th</sup> Meeting held on 07<sup>th</sup> & 08<sup>th</sup> July, 2016 has considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 18.07.2016. The institution did not submitted reply of Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov, 2019 has considered the matter and decided to issue Final Show Cause Notice in all such matters where reply to Show Cause Notice has not been submitted by the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 29.11.2019. The institution has not submitted reply of Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 408<sup>th</sup> Meeting held on 02<sup>nd</sup> March, 2022 the matter was placed before the Committee and decided to withdraw the recognition to the institution. Accordingly, as per decision of SRC withdrawal order was issued to the institution on 19.10.2020 vide order no. F.SRC/NCTE/APSO2006/B.Ed./2020/119643-9649.
- 6. **AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-142/E-256302/2022 Appeal/7<sup>th</sup> Meeting, 2022 APPLSRC202214347 dt. 19.10.2022 appeal remand back the order appealed against. The institution has submitted reply of appeal remand back on 13.12.2022.
- 7. AND WHEREAS, the SRC in its 418<sup>th</sup> Meeting held on 16<sup>th</sup> December, 2022 has considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Goutham B.Ed. College, Survey No. 822, Allipur,

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR)."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., Goutham B.Ed. College, Survey No. 822, Allipur, Hospet Road, Bellary 583104, Karnataka run by Bellary Educational Services Trust, Bellary, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 100 students subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) and fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.

- Fee charged from students. e.
- Available infrastructural facilities. f.
- Facilities added during the last quarter. g.
- Number of books in the library, journals subscribed to and additions, if any, in the h. last quarter.
- The affidavit with enclosure submitted along with application. i.
- The institution shall be free to post additional relevant information if it so desires. j.
- Any false or incomplete information on website shall render the institution liable for k. withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display 12. up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 13.
- The institution shall fill the information on GIS Portal on the NCTE Website. 14.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
