**CONTINUATION ORDER**

**WHEREAS**, the institution namely **Indian College of Education, Raziya Manzil, Chidri, Bidar District, Karnataka - 585403** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/9079 dated 02.12.2004 for **Secondary B.Ed.** course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 28.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting **B.Ed. course of two years duration** with an annual intake of 100 students for **two basic units** from the academic session 2015-16, subject the condition that to shift the institution to its own premises.

3. **AND WHEREAS**, the SRC in its 318<sup>th</sup> meeting held on 08<sup>th</sup> & 09<sup>th</sup> August 2016 considered the matter and decided to issue a letter to the institution intimating the decision. A letter was issued to the institution on 16.11.2016.

4. **AND WHEREAS**, the SRC in its 377<sup>th</sup> meeting held on 03<sup>rd</sup> & 04<sup>th</sup> July 2019 considered the matter and decided to issue Final SCN u/s 17 of NCTE Act 1993 before withdrawal of the recognition on the grounds mentioned to the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 19.07.2019. The institution was not submitted reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September 2020 considered the matter and decided to withdraw order. Accordingly, as per the decision of SRC a withdrawal order no. F.SRO/NCTE/APS02435/B.Ed./KA/2020/118700-8706 dated 24.09.2020 was issued to the institution.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-54/E-176645/2021 Appeal/10 Mtg.-2021/26<sup>th</sup> February 2021 dated 26.03.2021 appeal remand back the Order appealed against. The institution vide letter dt. 13.04.2021 submitted reply to the appeal remand the case.

7. **AND WHEREAS**, the matter was considered by the SRC in its 399<sup>th</sup> Meeting held on 15<sup>th</sup> & 16<sup>th</sup> June 2021 decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*



*The Committee noted the Appellate Authority order dated 26.3.2021 and accepted the contention of the institution vide letter dated 13.4.2021 that the institution is functioning in the own land and building from the date of recognition to till date.*

*On perusal of the order of the Appellate Authority and the reply dated 13.4.2021 submitted by the institution, decided that the **continuation order** be issued to the Institution **Indian College of Education, Survey No.41/P1 & 112/1-C Raziya Manzil, Chidri, Bidar District-585403, Karnataka for B.Ed. programme for 2 basic units of 50 students each.**"*

**8. NOW THEREFORE, the SRC decided to permit the institution i.e., Indian College of Education, Survey No.41/P1 & 112/1-C Raziya Manzil, Chidri, Bidar District-585403, Karnataka for B.Ed. course run by Indian Education Society, Chidri-Bidar, Branch – Bysandra, Bangalore-585403 for continuation of recognition for B.Ed. programme of two years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:**

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
10. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  13. The institution shall make available the list of students admitted on its official website.
  14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
