CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely **Sidhartha B.Ed. College, House No. 8, Mig-II, Housing Board Colony, Bhalki, Bidar-585328, Karnataka** vide SRC (NCTE) order No. F.SRC/NCTE/2009/B.ED/RO/14865 dated 30.07.2009 for conducting **B.Ed. course** of one-year duration with an annual intake of **100** students from the academic session 2009-2010.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated **27.01.2015**. A revised provisional recognition order (RPRO) was issued to the institution on **15.05.2015** for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 students (**two basic units**) from the academic session **2015-2016**.

3. **AND WHEREAS**, the matter was placed the SRC in its 369th meeting held on 28.01.2019. The Committee decided to issue Show Cause Notice to all such institution which have not submitted compliance of the revised recognition order. Accordingly, a Show Cause Notice was issued to the institution on 25.04.2019. The institution has not submitted reply to the Show Cause Notice.

4. **AND WHEREAS**, the matter was considered by the Sub-Committee constituted by the SRC as per decision taken in its 380th meeting 18th – 19th September, 2019. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 15.10.2019. The institution vide letter dated 08.11.2019 submitted reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 383rd meeting held on 07th – 09th January, 2020 considered the matter and decided to withdraw the recognition for conducting B.Ed. Course. Accordingly, as per the decision of SRC a Withdrawal Order no. F.SRO/NCTE/APS09787/B.Ed/KA/2020/114105-4111 was issued to the institution on 20.01.2020.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-112/E-158612/2020 Appeal/24th Mtg.-2020/23rd October 2020 dated 19.11.2020 appeal remand back the order appealed against. The institution has not submitted reply to the appeal remand back case.

7. **AND WHEREAS**, the matter was placed before the SRC in its 393rd meeting held on 5th-6th January 2021 decided to issue withdraw the recognition for conducting B.Ed. Course. Accordingly, as per the decision of SRC the Withdrawal Order vide order no. F.SRO/NCTE/APSO9787/B.Ed/KA/393rd/2021/123085-3091 was issued to the institution on 19.01.2021.

8. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-110/E-180313/2021 Appeal/14th Mtg.-2021/29th May,2021 dated 04.06.2021 appeal remand back the order appealed against. The institution vide letter dated 09.06.2021 submitted reply to the appeal remand back order.

9. **AND WHEREAS**, the matter was further considered by the SRC in its 399th meeting held on June 15th – 16th, 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Sidhartha B.Ed. College, Plot No. 5-4-208(Old) 5-4-225 (New) At. Sq. No.-115 Gunj Area Bhalki, Bidar-585328, Karnataka for B.Ed. programme for 2 basic units of 50 students each.**"*

10. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Sidhartha B.Ed. College, Plot No. 5-4-208(Old) 5-4-225 (New) At. Sq. No.-115 Gunj Area Bhalki, Bidar-585328, Karnataka** run by **Panchasheela Education Trust, House No. 8, Mig-II, Housing Board Colony, Bhalki, Bidar, Karnataka** for continuation of recognition for B.Ed. Programme for two years duration with an annual intake of **(2 basic units)** of 50 students each subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
The institution shall be free to post additional relevant information, if it so desires.
- j. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

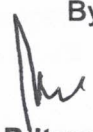
14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
