WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution **Assefa College of Education, Sillarpatty Village & Post, Peraiyur Taluk, Madurai District-625702, Tamilnadu run Association for Sarva, Seva Farms, No.279, Avvai Shanmugam Salai, Royappettah, Chennai-14, Tamilnadu** vide SRC order No. F.SRO/NCTE/B.Ed./2008/6011 dt. 10.10.2008 for conducting (**B.Ed.**) course of one-year duration with an annual intake of 100 students.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations notarized affidavit dated 27.02.2015. A revised provisional recognition order was issued to the institution on 05.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 has considered the matter and the Committee decided to issue a First Show Cause Notice. Accordingly, a First Show Cause Notice was issued to the institution on **20.12.2019**. The institution vide dated **07.01.2020** submitted reply in response to First Show Cause Notice.

4. AND WHEREAS, the SRC in its 385th meeting held on 03rd March 2020 has considered the matter and the Committee decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on **05.03.2020**. The institution vide dated **13.03.2020** submitted reply in response to Final Show Cause Notice.

5. AND WHEREAS, the matter was further considered by the SRC in its 399th meeting held on June 15th - 16th, 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution vide letter dated 13.03.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

1. The institution has submitted a Notarized copy of Faculty list consisting of 10 Lecturers against the requirement of 1 + 15 Faculty List.
2. The institution has submitted a Notarized copy of Building Plan in which size of Multi-purpose Hall Area is not as per NCTE Norms.

3. The institution has submitted a Notarized copy of BCC which is not approved by the Competent Authority.
4. The institution has not submitted a copy of Form "A" issued by the Branch Manager. Only photocopy of FDRs of Rs. 5 lakhs & 3 lakhs. The institution is required to submit a FDRs of Rs. 4 Lakhs.

Hence, the Committee decided to **withdraw the recognition** granted to **Assefa College of Education, Sillarpatty Village & Post, Peraiyur Taluk, Madurai District-625702, Tamilnadu** for conducting **B.Ed.** course with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Assefa College of Education, Sillarpatty Village & Post, Peraiyur Taluk, Madurai District-625702, Tamilnadu** run by **Association for Sarva, Seva Farms, No.279, Avvai Shanmugam Salai, Royappettah, Chennai-14, Tamilnadu** for conducting **B.Ed. course** of two years duration with an annual intake of **100** students (2 units) w.e.f. the next academic session i.e., 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
