WHEREAS, the recognition was granted to the institution Yadava College of Education, Yadava College, Thiruppalai, Madurai North Town, Madurai-625014, Tamilnadu run Yadava College, Govindarajan Campus, Thiruppalai, Madurai, Tamilnadu vide SRC order No.F.SRC/NCTE/2009/B.Ed./RO/14771 dt. 24.07.2009 for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2009-2010.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations notarized affidavit dated 19.01.2015. A revised provisional recognition order was issued to the institution on 21.04.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the institution VT inspection was conducted on 18.11.2016 and received on 22.11.2016. The SRC in its 388th meeting held on 14th 15th Sept 2020 considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 23.09.2020. The institution submitted reply in response to Show Cause Notice on 28.10.2020.
- **4. AND WHEREAS,** the SRC in its 399th meeting held on June 15th 16th, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 28.10.2020 in respect to the Show Cause Notice and found the following deficiencies: -

- 1. The institution has submitted a BCC in which total built-up area is 1214.05 sqm. which is less than the requirement of 2000 sqm. as per NCTE Norms.
- 2. The institution has submitted a photocopy of Land document, LUC, NEC, Building Plan, BCC instead of notarized copy of these documents.
- 3. The institution has not submitted a copy of the Site Plan.
- 4. The institution has not submitted "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh.

Hence, the Committee decided to withdraw the recognition granted to Yadava College of Education, Yadava College, Thiruppalai, Madurai North Town, Madurai-625014, Tamilnadu for conducting B.Ed. course with effect from the

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Yadava College of Education, Yadava College, Thiruppalai, Madurai North Town, Madurai-625014, Tamilnadu run by Yadava College, Govindarajan Campus, Thiruppalai, Madurai, Tamilnadu for conducting B.Ed. course of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
