ORDER

The recognition us/14(1) of NCTE Act,1993 was granted to the institution namely, Seethi Sahib Memorial Teacher Training Institute, Seethi Sahib Charitable Trust, P.O. Nellikkaparamba, Mukkom, Kozhikode District, Kerala-673602 vide SRC (NCTE) order no. F.KL/ELE/N/82/SRO/NCTE/2004-2005/6031 dt. 12.08.2004 for conducting Elementary course of two years duration with an annual intake of 100 students (50 Malayalam and 50 English) from the academic session 2004-05.

The SRC in its 412th Meeting held on 05th& 06thJuly, 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institutions seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of the SRC, a Show Cause Notice was issued to the institution on 02.08.2022 but, the institution has failed to submit the reply of the said Show Cause Notice.

Thereafter, the Final Show Cause Notice was issued to the institution on 07.09.2022. The institution failed to reply to the Final Show Cause Notice.

The SRC in its 415th Meeting held on 03rd& 04thNovember, 2022 considered the matter and decided to issue to issue Withdrawal order. Accordingly, as per the decision of SRC, the Withdrawal order was issued to the institution vide order no. F.SRC/NCTE/APSO0824/D.EI.Ed./{KL}/2022/137454-137458on 24.11.2022.

Aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-37/E-289703/2023 Appeal/5th Meeting, 2022 APPLSRC202214546 dt. 22.05.2023 has confirmed the withdrawal order dated 24.11.2022.

The institution filed a Writ Petition before Hon'ble High Court of Delhi at New Delhi bearing W.P.(C) No. 9260/2023 titled as Seethi Sahib Memorial Teacher Training Institute vs. NCTE & Anr Whereby the Hon'ble High Court has directed that:-

"18. Taking into consideration the aforesaid facts and circumstances in the instant case, this court finds it necessary to set aside the impugned order dated 24.11.2022 and the order passed by the appellate authority dated 22.05.2023. The matter is remitted back to the SRC with liberty to take fresh action against the petitioner, if so required, in accordance with law.

- 19. The petitioner is directed to file the reply to the Show Cause Notice dated 02.08.2022 within a period of 15 days from today.
- 20. The concerned SRC will take the final decision with respect to the withdrawal of the recognition or otherwise of the petitioner-institution, in accordance with law.
- 21. In the meantime, the petitioner would be entitled to take part in the counselling etc. if the same takes place. The further course of action will depend upon the decision to be taken by the concerned SRC. All consequential steps be taken by the concerned SRC including the issuance of order of restoration and also its communication to all concerned.
- 22. With the aforesaid directions, the petition stands disposed of alongwith pending application."

Accordingly, in view of the order dt. 22.08.2023 passed by the Hon'ble High Court of Delhi, the status of Seethi Sahib Memorial Teacher Training Institute, Seethi Sahib Charitable Trust, P.O. Nellikkaparamba, Mukkom, Kozhikode District, Kerala-673602 for D.El.Ed. Programme two years duration with an annual intake 100 (50 Malayalam and 50 English) students stands recognised and is entitled to the benefits of recognition until and unless fresh withdrawal order is passed. However, the same will remain subject to further orders to be passed by the SRC in terms of the order passed by the Hon'ble High Court of Delhi on 22.08.2023.
