ORDER

WHEREAS, recognition was granted to the institution namely Vinayaka Mission's Research Foundation Faculty of Education, No. C-182, Cuddalore Main Road, Thavalakuppam, Pondicherry - 605007 vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2006-2007/10103 dt.19.01.2007 for conducting M.Ed. course of one year' duration with an annual intake of 25 students from the academic session 2006-2007.

AND WHEREAS, the institution vide letter 14.10.2016 & date has again requested for closure of M.Ed. course.

AND WHEREAS, vide letter no. F.No.SRO/NCTE/APSO6018/M.Ed./PO/2016-17/89326 dt.25.10.2016 the institution was directed to submit the following documents:

1. NOC from the affiliating body.
2. No dues from staff.

The institution did not submit any reply .

And whereas, the SRC in its 379th meeting held on 21st - 22nd August, 2019 considered the matter and decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to **withdraw the recognition** granted to Vinayaka Mission's Research Foundation Faculty of Education, No.C-182, Cuddalore Main Road, Thavalakuppam, Pondicherry - 605007 for conducting M.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the request of the institution. However, the Reserve Fund and Endowment Fund will be refunded by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraws recognition of Vinayaka Mission's Research Foundation Faculty of Education, No. C-182, Cuddalore Main Road, Thavalakuppam, Pondicherry - 605007** granted SRC vide order no. F.SRO/NCTE/M.Ed./2006-2007/10103 dt.19.01.2007 for conducting M.Ed. course of one year' duration with an annual intake of 25 students from the next academic session starts after issuance of this order. The provisional revised recognition orders No.F.SRO/NCTE/APSO6018/M.Ed/TN/2015/665790 dt. 28.5.2015 issued to the institution in respect of M.Ed course of 2 years duration with an annual intake of 100 seats is also hereby withdrawn.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through “Online mode” available on NCTE’s website <http://ncte.gov.in> , within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
