WHEREAS, the recognition was granted to the institution namely A.M. Linganna College of Education, Sevamandir-515212, Hindupur, Ananthapur District, Andhra Pradesh run by Sevamadir, Anathapur District, Andhra Pradesh vide SRC (NCTE) order no. F. SRO/NCTE/B.Ed/2006-2007/837 dt. 14.04.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students for the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.

AND WHEREAS, the institution submitted written representation on 17.08.2015 requesting for issuance of corrigendum as the institution was granted 1 unit in its B.Ed. course. Accordingly a corrigendum dated 27.10.2015 was issued to the institution for fulfillment of certain conditions mentioned therein.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 26.02.2019. The institution has submitted the reply vide dated 14.03.2019 in response to the Show Cause notice. The SRC in its 394th Meeting held on 27th – 28th January, 2021 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 04.03.2021. The institution has submitted reply to the Final Show Cause Notice vide dated 18.02.2021.

AND WHEREAS, the matter was finally considered by the SRC in its 397th meeting held on 25th-26th March 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution vide letter dated 18.02.2021 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The land document submitted at the time of initial recognition was sale Deed executed on 29.10.1940 favour of "Kuruba Business linganna". Whereas the land document submitted in compliance of RPRO is a Gift Deed executed on 25.05.2015 in favor of "Sevamandir Society" with survey No.254-2. The same is contradictory.
- 2. The institution has submitted copy of Building Plan in which Multipurpose Hall is not sufficient as per NCTE Regulations 2014 and not approved by competent authority.
- 3. The institution has submitted approval letter of faculty issued by the Registrar Sri Krishnadevaraya University vide dated 15.02.2021.

- (i) 2 Assistant Professor does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
- 4. The institution has not submitted Form A towards creation of FDR for Endowment Fund & Reserve Fund.

Hence, the Committee decided to withdraw the recognition granted to A.M. Linganna College of Education, Sevamandir-515212, Hindupur, Ananthapur District, Andhra Pradesh for conducting B.Ed. course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of A.M. Linganna College of Education, Sevamandir-515212, Hindupur, Ananthapur District, Andhra Pradesh run by Sevamadir, Anathapur District, Andhra Pradesh for conducting B.Ed. programme of two-year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
