**CORRIGENDUM**

The decision of SRC taken in 401<sup>st</sup> meeting held on 11<sup>th</sup> & 12<sup>th</sup> August 2021, of order no. F.No. FSRO/NCTE/APSO2328/B.Ed./KA/2021/128360 dated 24.08.2021 has been reviewed in its 404<sup>th</sup> meeting held on 16<sup>th</sup> & 17<sup>th</sup> November, 2021 and decided as under:-

*"In compliance of order dated 27.10.2021 passed by Hon'ble High Court of Delhi in writ petition no. 12130/2021 titled as Rajeev College of Education Versus National Council for Teacher Education and another, the Committee has decided that, Rajeev College of Education, Lalitha Krupa Building, B.M. Road, Hassan-573201, Karnataka will be entitled to participate in the counselling for the academic session 2021-2022. The Committee further decided to upload the website of SRC accordingly. The Committee further decided to communicate the recognition status of the petitioner to the Affiliating University and the State Government however the withdrawal of the recognition to Rajeev College of Education stands effective from the academic session 2022-23.*

*Accordingly, RD, SRC is advised to issue modification orders / corrigendum in this regard.*

**NOW THEREFORE**, the decision in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, in respect of withdrawal of recognition of Rajeev College of Education, Lalitha Krupa Building, B.M. Road, Hassan-573201, Karnataka vide order No. FSRO/NCTE/APSO2328/B.Ed./KA/2021/128360 dated 24.08.2021 may be read as with effect from the academic session 2022-2023 onwards instead of from the academic session 2021-2022 onwards for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the academic session i.e., 2022-2023 onwards.

**Other contents of order No. F. No.FSRO/NCTE/APSO2328/B.Ed./KA/2021/128360 dated 24.08.2021 shall remain unchanged.**
