WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Dharmaguru B.Ed. College, 13th Ward, Behind Munciff Court, Bagepalli Town, Kolar District, Karnataka - 560004 vide order no. F.SRO/NCTE/B.Ed./2004-2005/9588 dated 24.12.2004 for conducting Secondary (B.Ed.) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 25.06.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 01.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 Students (one basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, the institution has submitted a written representation dt. 30.10.2015 requested for permitting to change of premises.
- 4. AND WHEREAS, the SRC in its 329th Meeting held on 06th & 07th February, 2017 considered the matter and observed as under: -
 - "The facts are jumbled. Land documents are all not on record. Office should carefully check the details and put up a clearer agenda note."
- 5. AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September, 2020 the matter was considered and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 01.09.2022. The institution has submitted its reply to Show Cause Notice on 14.09.2022.
- 6. AND WHEREAS, the SRC in its 414th meeting held on 26th 27th September, 2022 has considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:

The Committee considered the Representation/Application submitted by the institution and the Committee decided to constitute the online <u>Visiting Team</u> for shifting of premises for inspection of infrastructural & instructional facilities etc. of Sri Dharmaguru B.Ed. College, 13th Ward, Behind Munciff Court, Bagepalli Town, Kolar District, Karnataka for the existing courses alongwith an advice to verify and check the adherence of compliance of conditions stipulated under NCTE Regulations, 2014."

- 7. **AND WHEREAS**, accordingly, as per the decision of SRC a letter was issued to the institution on 17.02.2023. The institution has submitted vide letter dated 23.02.2023 revalidated DD no. 057894 of Rs 1,50,000/-.
- **8. AND WHEREAS,** the inspection of the institution has conducted on 05.09.2023 & 06.09.2023 and Visiting Team report received on 06.09.2023.
- 9. AND WHEREAS, the SRC in its 429th Meeting held on 11th October, 2023 has considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 25.10.2023. The institution has submitted reply of Show Cause Notice vide letter dt. 06.11.2023.
- 10. AND WHEREAS, the SRC in its 431st Meeting held on 10th January, 2024 has considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 25.01.2024. The institution has submitted reply of Final Show Cause Notice vide letter dt. 31.01.2024.
- 11. AND WHEREAS, the SRC in its 433rd Meeting held on 10th February, 2024 has considered the matter and decided as follows: -

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on perusal of the reply submitted by the institution namely Sri Dharmaguru B.Ed. College decided that shifting of premises be permitted to the institution at new address i.e., Survey No. 401, Next to Fire Station, Teemakalapalli II Block, Paragodu Grama Panchyat, Bagepalli Taluk, Chikkaballapura District- 561207, Karnataka. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 1 basic units of 50 students."

- 12. NOW THEREFORE, this order is issued permitting the institution i.e., Sri Dharmaguru B.Ed. College, 13th Ward, Behind Munciff Court, Bagepalli Town, Kolar District, Karnataka to shift its building at new address at Survey No. 401, Next to Fire Station, Teemakalapalli II Block, Paragodu Grama Panchyat, Bagepalli Taluk, Chikkaballapura District-561207, Karnataka. Further as per the decision of SRC, an order for continuation of recognition also issued for B.Ed. course of two years duration with annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 14. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.

18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
