WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Little Rose College of Education, Plot no. 5-4, Main Road, Venkatayapalem Village, Draksharama Post, Ramachandrapuram Taluk, East Godavari District, Andhra Pradesh-533262 run by Elite Educational Society, Drakshanama Post, Ramachandrapuram Taluk, East Godavari District, Andhra Pradesh-533262 vide order no. SRO/NCTE/SRCAPP14786/M.Ed./AP/2018-2019/97354 dt. 22.05.2018 for conducting M.Ed. course of two years duration with an annual intake of 50 students from the academic session 2019-2020.

- 2. AND WHEREAS, the institution has submitted a written representation vide dt. 11.02.2024 request to closure of M.Ed. Programme.
- 3. AND WHEREAS, the SRC in its 434th Meeting held on 22nd March, 2024 has considered the matter and decided as under: -

"The original file of the institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 11.02.2024 by withdrawing the recognition granted to Little Rose College of Education, Plot no. 5-4, Main Road, Venkatayapalem Village, Draksharama Post, Ramachandrapuram Taluk, East Godavari District, Andhra Pradesh-533262 for conducting M.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

The FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Little Rose College of Education, Plot no. 5-4, Main Road, Venkatayapalem Village, Draksharama Post, Ramachandrapuram Taluk, East Godavari District, Andhra Pradesh-533262 for conducting M.Ed. course of two years duration with an annual intake of 50 students from the academic session i.e., 2022-2023.
- **5.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained
