WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely, **Arcot Sri Mahalakshmi Women's College of Education, Arani Main Road, Vellapakkam, Vellore District, Tamilnadu-632521** vide SRC vide order no. F.TN/SEC/SRO/NCTE/2005-2006/5088 dt. 04.01.2006 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic sessions 2005-2006.

2. **AND WHEREAS**, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution on dt. 28.01.2015, and the provisional revised recognition order was issued on dt. 30.05.2015 to the institution for conducting **B.Ed. programme of two years duration with an annual intake of 100 students each for two basic units** from the academic session 2015-2016.

3. **AND WHEREAS**, the SRC in its 317<sup>th</sup> Meeting held on 28<sup>th</sup> to 30<sup>th</sup> July 2016 considered the request for change management matter and decided to issue a letter. Accordingly, as per decision of SRC a letter was issued to the institution on dt. 16.08.2016.

4. **AND WHEREAS**, the SRC in its 383<sup>rd</sup> meeting held on 07<sup>th</sup> & 09<sup>th</sup> January 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Show Notice was issued to the institution on 21.01.2020. The institution has submitted reply on 25.02.2020.

5. **AND WHEREAS**, the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> - 12<sup>th</sup> August, 2021 considered the FSCN reply matter and decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 25.02.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.*

- 1. The institute previously requested for change of Management which was informed by the SRC with disapproval. Now with the reply of FSCN dt. 21.01.2020 the institute had submitted a notarized copy of Gift Deed dt. 31.10.2013 which is in favour of Sri Matha Bhavenseswari Educational Trust (Donee) which is not the managing trust of the college. The Managing Trust is Mahalakshmi Educational Charitable Trust. This is not permissible under clause 8 (4) (i) of NCTE Regulations, 2014.*
- 2. Other documents like BCC, NEC, building plan and LUC etc., cannot be accepted on the face of deficiency in land documents.*

3. Faculty for B.Ed., M.Ed. and D.T.Ed. courses has not been submitted with the latest approval of affiliating body. Only approval of 2015 is submitted only for M.Ed. course.
4. The Website of the institute is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to **withdraw the recognition** granted to **Arcot Sri Mahalakshmi Women's College of Education, Arani Main Road, Vellapakkam, Vellore District, Tamilnadu-632521** for conducting **B.Ed., M.Ed. and D.T.Ed.** programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Arcot Sri Mahalakshmi Women's College of Education, Arani Main Road, Vellapakkam, Vellore District, Tamilnadu-632521** run by **Sri Matha Bhuvaneshwari Educational Trust, Arcot-Arni Main Road, Vilapakkam post, (Near) Arcot, Tamilnadu-632521** for conducting **B.Ed. programme** of two years duration with effect from the academic session i.e., 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

*"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."*

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
