WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely, **A.E.T. College of Education, Swarnasandra, M.C. Road, Mandya-571402, Karnataka** vide SRC vide order no. F.SRO/NCTE/B.Ed/2004-2005/9224 dt. 09.12.2004 for Secondary (**B.Ed.**) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 02.07.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 for two basic units of 50 students each** from the academic session 2015-16.

3. **AND WHEREAS**, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22<sup>nd</sup> Oct., 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply been submitted. The Sub-Committee decided to issue SCN. Accordingly, as per the decision of SRC First Show Cause Notice was issued to the institution on 23.10.2019. The institution has not submitted reply to the First Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 06.10.2020. The institution has submitted reply on 19.11.2020.

5. **AND WHEREAS**, the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> - 12<sup>th</sup> August, 2021 considered the matter and decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 19.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.*

- 1. The faculty is not approved by the Affiliating body.*
- 2. The institute submitted a copy of building plan but the same is neither legible nor approved by the competent authority.*
- 3. The institute did not submit the Non-Encumbrance Certificate.*
- 4. The institute did not submit the Land Use Certificate issued by the Competent authority.*

5. *The Website of the institute is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.*

Hence, the Committee decided to **withdraw the recognition granted to A.E.T. College of Education, Swarnasandra, M.C. Road, Mandya, Karnataka-571402 for conducting B.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.**

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **A.E.T. College of Education, Swarnasandra, M.C. Road, Mandya, Karnataka-571402** for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students (2 basic units)** w.e.f. the next academic session i.e., 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

***“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”***

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
