WHEREAS, the recognition was granted to the institution namely, Rajeev College of Education, Lalitha Krupa Building, B.M. Road, Hassan, Karnataka-573201 vide SRC vide order no. F. SRO/NCTE/B.Ed./2004-2005/8751 dt. 29.11.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, the permission accorded to shift the institution to its new permanent premises at Rajeev College of Education, Sampige Road, K.R. Puram, Hassan District, Karnataka-573201 vide order no. F.No.APSO2328-B.Ed./KA/2011-12/38947 on 02.03.2012.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 08.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- **4. AND WHEREAS,** the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October, 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply. Accordingly, as per the decision of SRC First Show Cause Notice was issued to the institution on 24.10.2019. The institution has submitted reply on 20.11.2019.
- **5. AND WHEREAS,** the SRC in its 387^{th} meeting held on $24^{th}-25^{th}$ August, 2020 considered the reply and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 01.09.2020. The institution has submitted reply on 21.09.2020.
- **6. AND WHEREAS,** the SRC in its 401st meeting held on 11th 12th August, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated21.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution submitted a copy of building plan but the same is neither approved nor legible.

- 2. LUC does not show total land area, area of Multipurpose Hall not mentioned in the building plan and BCC.
- 3. The institution has submitted staff list as 1+7 against the requirement of 1+15 for 2 basic units of B.Ed. course as per NCTE Regulations 2014.

Hence, the Committee decided to withdraw the recognition granted to Rajeev College of Education, Lalitha Krupa Building, B.M. Road, Hassan-573201, Karnataka for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Rajeev College of Education, Lalitha Krupa Building, B.M. Road, Hassan-573201, Karnataka run by Rajeev Education Trust, Sampige Road, Hassan Karnataka-573201 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
