WHEREAS, the recognition was granted to the institution namely, G.M. College of Education, G.M. Campus, Arishinakunte Village, Nelamangala Bypass, Bangalore Rural District, Karnataka run by G.M Educational Trust, Bangalore, Karnataka vide SRC vide order no. F.SRO/NCTE/B.Ed./2005-2006/5164 dt. 16.01.2006 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 03.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in 369th meeting held on 28.01.2019 considered the matter and decided to issue SCN to all such institution which have not submitted the compliance in respect of Revised Recognition Orders. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 29.05.2019. The institution has not submitted reply to the Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 04.03.2021. The institution has not submitted the reply to the Final Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 401st meeting held on 11th 12th August, 2021 considered the non submission of FSCN reply matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) on 04.03.2021. The institution failed to submit reply to the Final Show Cause Notice.

Hence, the Committee decided to withdraw the recognition granted to G.M. College of Education, G.M. Campus, Arishinakunte Village, Nelamangala Bypass, Bangalore Rural District, Karnataka for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to G.M. College of Education, G.M. Campus, Arishinakunte Village, Nelamangala Bypass, Bangalore Rural District, Karnataka-562123 run by G.M Educational Trust, Bangalore, Karnataka for conducting B.Ed. programme of two years duration with effect from the academic session i.e., 2021-2022 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
