WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Kumadvathi College of Education, Shimoga Road, Shikaripur-577427, Shimoga District, Karnataka** run by **Swamy Vivekananda Vidya Samsthe, Shimoga District – 577427, Karnataka** vide SRC vide order no. F.KR/B.Ed./New/SRO/NCTE/2000-2001/1591 dt. 16.08.2000 for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 17.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units of 50 students each** from the academic session 2015-16.

3. **AND WHEREAS**, a Corrigendum was issued to the institution vide order no. F.SRO/NCTE/APS03313/B.Ed./KA/2015/68979 dt. 30.06.2015 for grants recognition to **Kumadvathi College of Education, Shimoga Road, Shikaripur, Shimoga district, Karnataka-577427** for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.

4. **AND WHEREAS**, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October, 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 24.04.2019. The institution did not submit reply to the Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 388th meeting held on 14th – 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 13.10.2020. The institution has submitted reply on 31.10.2020.

6. **AND WHEREAS**, the SRC in its 401st meeting held on 11th - 12th August, 2021 considered the FSCN reply matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 03.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. Proforma of faculty has been signed by the Registrar, Kuvempu University but the date of approval 22.11.2019 has been mentioned only on two pages of proforma and not mentioned all pages.
2. Faculty namely Jayashree V Rakkasagi and Kiran Kumar K are having less than 55% marks in P.G. and not qualified as per NCTE Regulations, 2014.
3. Documents of managing society/trust of the college not submitted.
4. The building plan submitted is neither approved by the competent authority nor legible.
5. The Website of the institute is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
6. The institution did not submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details:
 - (i) Details of land & building available at the time of recognition with the Institution.
 - (ii) Details of land & building now available with the Institution.
 - (iii) Status of Management at the time of recognition and its present status.

Hence, the Committee decided to **withdraw the recognition** granted to **Kumadvathi College of Education, Shimoga Road, Shikaripur-577427, Shimoga District, Karnataka** for conducting **B.Ed. programme** with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Kumadvathi College of Education, Shimoga Road, Shikaripur-577427, Shimoga District, Karnataka** run by **Swamy Vivekananda Vidya Samsthe, Shimoga District – 577427, Karnataka** for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2021-2022 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
