WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution **TMAE College of Education, Harapanahalli-583131, Davanagere District, Karnataka** vide SRC vide order no. F.KAR/B.Ed./41/SRO/NCTE/2000-2001/1074 dt. 13.07.2000 for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units of 50 students** each from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 369th meeting held on 28th January, 2019 considered the matter and decided to issue SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, as per decision Show Cause Notice was issued to the institution on 29.05.2019. The institution vide letter dated 27.07.2020 request change of name.

4. **AND WHEREAS**, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 21.10.2020. The institution has submitted reply on 02.11.2020.

5. **AND WHEREAS**, the SRC in its 401st meeting held on 11th - 12th August, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 02.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies: -



1. The institution has submitted photocopy of Land Document instead of certified one.
2. Total area mentioned in Building Plan and Building Completion Certificate do not match and not sufficient.
3. The institution has submitted notarized copy of Building Plan in which Built-up area is not sufficient.
 - a. Survey No. not mentioned.
 - b. The name & stamp of issuing authority both are in regional language.
 - c. The size of Multipurpose Hall is less than the requirement of NCTE Regulations
4. The total area mentioned in Land Document & Building Completion Certificate do not match with each other.
5. The institution has submitted photocopy of faculty list signed by the Registrar of the University, but approval letter of affiliating body not submitted.
6. Percentage of marks in r/o Principal in Post-Graduation at (S.No.1) is less than 55% & Ph. D degree is not mentioned.
7. Date of joining of all staff is not mentioned in Staff list.
8. The date of approval of faculty is not mentioned, only date of notary is available.
9. The website of the institution is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to **withdraw the recognition** granted to **T.M.E.A. College of Education, Harapanahalli-583131, Davanagere District, Karnataka** for conducting **B.Ed. programme** with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **T.M.E.A. College of Education, Harapanahalli-583131, Davanagere District, Karnataka** run by **Sri Tegginamath Arts & Education Society, Davanagere District, Harapanahalli, Karnataka-583131** for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students (2 basic units)** w.e.f. the next academic session i.e., 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education

obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
