WHEREAS, the recognition was granted to the institution Sri T.V. Venkataswamy College of Education, Madhugiri, Tumkur District, Karnataka-572132 vide SRC vide order no. F.KAR/B.Ed./25/SRO/NCTE/2000-2001/1057 dt. 13.07.2000 for B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 09.01.2014 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units of 50 students** each from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 291st meeting held on 20th & 21st August 2015, considered the matter and decided to restored B.Ed. course. Accordingly, as per decision of SRC vide order no. F.No./SRC/NCTE/APSO3481/B.Ed./KA/2015/75541 dt. 09.10.2015 was issued to the institution Restored Recognition.

4. AND WHEREAS, a Corrigendum was issued to the institution vide order no. F.SRO/NCTE/APSO3481/B.Ed./KA/2015-2016/77301 dt. 03.11.2015 for grants of recognition to the institution for conducting B.Ed. programme of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-2016.

5. **AND WHEREAS**, the matter regarding compliance by the institution of the conditions of the revised recognition order, was placed before the SRC in its 369th Meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 01.07.2019. The institution has not submitted reply to the Show Cause Notice.

6. **AND WHEREAS**, the SRC in its 381st Meeting held on 31st & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 20.12.2019. The institution has submitted reply on 18.03.2020.

7. AND WHEREAS, the SRC in its 401st meeting held on 11th - 12th August, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on18.03.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institute did not submit certified /notified copy of LUC and Land Documents only self-certified copy submitted.
- 2. The multipurpose Hall is only having size of 18.23 X 6.00 sq. mt. (109.38 sq. mtr.) which is less than the requirement stipulated under NCTE Regulations, 2014.
 - 3. Faculty is not approved by the affiliating body.
 - 4. The institution has submitted Building Plan which is not approved by Competent authority.
 - 5. Affidavit has not been submitted.
 - 6. Form 'A' issued by the bank towards FDRs of EF & RF has not been submitted.
 - 7. The Website of the institute is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to **withdraw the recognition** granted to **Sri T.V. Venkateswamy College of Education, Madhugiri, Tumkur District, Karnataka-572132** for conducting **B.Ed.** programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri T.V. Venkateswamy College of Education, G.B.N. Road, Madhugiri, Tumkur District, Karnataka-572132 run by Madhugiri Education Society for conducting B.Ed. programme of two years duration with effect from the academic session i.e., 2021-2022 onwards.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
