WHEREAS, the recognition was granted to the institution namely, Good Shephered College of education, 31/6m, 18B, Holy Cross College Road, Nagereoli, Kanyakumari District, Tamilnadu-629004 was granted recognition vide SRC (NCTE) order no. F.TN/SRO/NCTE/2005-2006/4105 dt. 21.11.2005 for Secondary (B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- **2. AND WHEREAS,** the SRC in its 216th meeting held on 11th 12th January, 2012 considered the VT report matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.No. APSO3681/B.Ed/TN/2011-12/39037 dated 07.03.2012 was issued to the institution.
- 3. AND WHEREAS, a order vide no. F.No.APSO3681/B.Ed./TN/2011-12/45440 dt. 24.08.2012 permission is hereby accorded by SRC to Good Shephered College of Education, 31/6, 18B, Holy Cross College Road, Nagercoil, Kanyakumari District, Tamilnadu-629004 to shift its premises to the new location/building at Good Shephered College of Education, Holy Cross College Road, Nagercoil, Kanyakumari District, Tamilnadu-629004 restore recognition of the institution.
- 4. AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution on dt. 19.01.2015, and the provisional revised recognition order was issued on dt. 30.04.2015 to the institution for conducting **B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.**
- **5. AND WHEREAS,** on the basis of request, the SRC in its 343rd meeting held on 01st 02nd July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 20.09.2017 reduction of intake from 2 units to 1 unit.
- **6. AND WHEREAS**, the SRC in 369th meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such institutions which have not submitted compliance. Accordingly, as per decision of SRC Show Cause was issued to the institution on 03.05.2019. The institution has submitted reply on 23.05.2019.
- **7. AND WHEREAS**, the SRC in its 386th meeting held on 23rd-24th July 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 04.08.2020. The institution has not submitted reply to the Final Show Cause Notice.
- **8. AND WHEREAS**, the SRC in its 401st meeting held on 11th 12th August, 2021 considered the non-submission FSCN reply matter and decided as under: -

by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) on 04.08.2020. The institution failed to submit reply to the Final Show Cause Notice.

Hence, the Committee decided to withdraw the recognition granted to Good Shephered College of Education, Holy Cross, College Road, Nagercoil, Kanyakumari District-629004, Tamilnadu for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 9. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Good Shephered College of Education, Holy Cross, College Road, Nagercoil, Kanyakumari District-629004, Tamilnadu run by Geoby Educational Trust, 31/3, 18B, Holy Cross College Road, Nagercoil, Kanyakumari District, Tamilnadu-629004 for conducting B.Ed. programme of two years duration with effect from the academic session i.e., 2021-2022 onwards.
- **10.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
