**WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely **Amrutha College of Education, 1<sup>st</sup> Ward, Mulaguntapadu Village, Singarayakonda Mandal, Prakasam District-523101, Andhra Pradesh** run by **Amrutha Social Educational Development Society, Radham Bazar, Karedu, Ulavapadu Mandal, Prakasam District-523292, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/13127 dt.18.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt.17.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, The SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and decided as under;

1. RPRO cases were held back deliberately so that the new application cases can be attended to on priority.
2. On scrutiny it is seen that there are hundreds of RPRO cases in which the Institutions have not cared to take any action at all on the conditions listed in the RPROs. This kind of recalcitrance is not acceptable.
3. After due deliberation today, it has been decided that in all such cases SCNs should be issued for withdrawal of recognition.
4. Please take action accordingly and report compliance.
5. Put up these cases after 6 weeks or when replies are received whichever is earlier.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 31.01.2019. The institution vide letter dated 25.02.2019 submitted reply to the show cause notice. The SRC in its 374<sup>th</sup> meeting held on 09<sup>th</sup> – 10<sup>th</sup> April, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (i) Certified copy of land documents not submitted.
  - (ii) Building plan old and new are contrary to each other.
  - (iii) If the land is in the name of the Society, it should reflect in Encumbrance Certificate instead many Encumbrance Certificate were issued for different plots which is against NCTE norms.

Hence, the Committee decided to withdraw the recognition under Section 17 (1) of the NCTE Act.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Amrutha College of Education, Sy.No. 108, 1<sup>st</sup> Ward, Mulaguntapadu Village, Singarayakonda Mandal, Prakasam District-523101, Andhra Pradesh run by Amrutha Social Educational Development Society, Radham Bazar, Karedu, Ulavapadu Mandal, Prakasam District-523292, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 students (2 units) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
