Preamble:

Rastreeya Vidyalaya Teacher Training Institute, 2nd Block, Jayanagar, Bangalore – 560 ©11, Karnataka has been granted recognition with an intake of 30 students for D.Ed course on 01.10.1996.

The institution vide its letter dated 5.1.2009 has requested for permission to shift the R.V. Teacher Training Institute from 2nd Block, Jayanagar, Bangalore-560011 to new building located at Jayanagar IV Block, Bangalore. Accordingly, the inspection of the new location / building was carried out on 13.3.2009 and the visiting team report was placed before SRC in its 172nd meeting held during 25-26 March, 2009. The SRC decided to permit R.V. Teacher Training Institute for shifting from 2nd Block, Jayanagar, Bangalore to 4th Block, Jayanagar, Bangalore.

Accordingly, the institution has been permitted to shift the premises to the new location / building vide order No.F.SRO/NCTE/2009-2010/11971 dated 24.04.2009.

Now, the institution has submitted a request for refixation of intake from 30 to 50 on 1 9.08.2009. The institution has stated that it is an aided institution and it is not viable for the institution to manage with an intake of 30 students.

The institution has also stated that the institution is having necessary infrastructural & instructional facilities and faculty (1+5) for imparting quality teaching for 50 students.

The institution has submitted the following documents :

- 1. Certified copies of lease document with total land area of 1540.50 sq.mts.
- 2. Approved building plan with built up space of 2,641.12 sq.mts.
- 3. Bye-laws of the Trust
- 4. Details of Teaching faculty
- Permission letter from NCTE for shifting the campus.
- 6. Building completion certificate for built up space.
- 7. Demand Draft for Rs.40,000/-.

As per the notification published in Times of India dated 29.07.2009, there is a ban, not to further recognise / permit institutions for conducting D.Ed course in the State of Karnataka for the academic session 2010-2011.

The SRC in its 181st meeting held on 20-21 August 2009 considered the inspection report of the institution which was conducted on 13.3.2009 for shifting of premises for D.Ed.(30 intake) and found that the infrastructural and instructional facilities are adequate for D.Ed.(50 intake) i.e., one basic unit. In view of adequate infrastructural and instructional facilities posessed by the institution, the Committee considered the request of the institution for refixation of intake from 30 to 50 for D.Ed. course and decided to recommend to NCTE, HQ as it is not an additional batch but fulfilling strength norm of an already sanctioned intake.

Accordingly, a recommendation letter to NCTE, Hqrs has been sent on 11.09.2009 for re-fixation of intake from 30 to 50.

NCTE, Hqrs in its letter dated 21.10.2009 has stated that the matter was examined, in the light of NCTE Regulation 2009 vis-à-vis the Public Notice dated 28.07.2009 imposing ban on further grant of recognition to the teacher education institution and has decided to endorse the decision of the SRC in its 181st meeting for increase of seats of the institution from the existing 30 to 50 (one unit).

SRC in its 188th meeting held on 28-29 January 2010 considered the above matter and decided to enhance the strength from 30 to 50 in the existing basic unit

Hence the order.

ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Rashtreeya Sikshana Samithi Trust, Jayanagar, Bangalore – 560 011, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Rastreeya Vidyalaya Teacher Training Institute, 2nd Block, Jayanagar, Bangalore – 560 011, Karnataka for D.Ed Course of two year duration.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for offering D.Ed course with an intake of 30 students on 01.10.1996.

The institution vide its letter dated 5.1.2009 has requested for permission to shift the R.V. Teacher Training Institute from 2nd Block, Jayanagar, Bangalore-560011 to new building located at Jayanagar IV Block, Bangalore. Accordingly, the inspection of the new location / building was carried out on 13.3.2009 and the visiting team report was placed before SRC in its 172nd meeting held during 25-26 March, 2009. The SRC decided to permit R.V. Teacher Training Institute for shifting from 2nd Block, Jayanagar, Bangalore to 4th Block, Jayanagar, Bangalore.

Accordingly, the institution has been permitted to shift the premises to the new location / building vide order No.F.SRO/NCTE/2009-2010/11971 dated 24.04.2009.

AND WHEREAS, SRC in its 188th meeting held on 28-29 January 2010 considered the request of the institution for refixation of intake from 30 to 50 submitted on 19.08.2009 along with the letter from NCTE, Hqrs dated 21.10.2009 and decided to enhance the strength from 30 to 50 in the existing basic unit under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:
 - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE(Recognition Norms & Procedure) Regulations, 2007.
 - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

- Further, the recognition is subject to fulfillment of all such other requirements as 3 may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at 4. the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its Web-site as per provisions of NCTE 5. Regulations and always display following as mandatory disclosure:-
 - Copy of the Application Form
 - Land and Building Particulars (ii)
 - (iii) Staff Profile
 - (iv) Recognition letter
 - Information for having fulfilled the norms & standard and other required (v) conditions.
- If the institution contravenes any of the above conditions or the provisions of the 6. NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
