WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, S.V.S. College of Education, Martin Luther School Campus, 208, 15th Main, Nagendra Block, Banashankari 3rd Stage, Girinagar, Bangalore-560050, Karnataka run by Sri Venugopalaswamy Educational Trust, Bangalore, Karnataka vide order No. F.SRO/NCTE/B.Ed./2005-2006/5123 dated 06.01.2006 for conducting B.Ed. course of oneyear duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.23.01.2015 for its willingness of one unit in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-
- AND WHEREAS, the SRC in its 348th Meeting held on 05th & 06th December 2017 3. has considered the request for change of name decided as under:-
 - "1. Their reply to the SCN is not accompanied by FDRs and Faculty list in the prescribed formt. Obtain.
 - 2. The 'Change of name' aspect has not received attention. This will have consequential implications for all documents, esp. the lease dee. Ask them to explain the current status.
 - 3. Re-examine and resubmit on 15/12.
 - 4. We can send a composite SCN thereafter."
- AND WHEREAS, a letter was to the institution on 12.12.2017. The institution has submitted a reply on 30.01.2018. The SRC in its 383rd meeting held on 07th to 09th January 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC, a Final Show Cause Notice was issued to the institution on 16.01.2020. The institution submitted reply on 10.07.2020.
- AND WHEREAS, the SRC in its 401st meeting held on 11th 12th August 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRO/NCTE/APS03516/B.Ed./{KA}/2021/128366 was issued to the institution on 24.08.2021. The institution has submitted reply on 03.09.2021 requesting to reconsider the decision of Withdrawal order.
- AND WHEREAS, the SRC in its 402nd meeting held on 13th 14th September 2021 has re-considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 23.06.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- The initial recognition was granted to the institution namely S.V.S. College of Education under the management of Trust namely Sri Venugopal Swamy Educational Trust.
- 2. The Committee in light of letter No. ED476UBV2007 dt. 07.12.2007 issued by the Govt. of Karnataka and letter No. ACA-3/A3/SVSCE:2007-08 dt. 20.09.2007 issued by the Vice Chancellor, Bangalore University decided that the request of the institution regarding change of name of institution from S.V.S. College of Education to Anugraha B.Ed. College is accepted and rectified. The Committee also decided not to allow change in the name of the trust. Necessary change on the website of the SRC, NCTE be made.
- 3. The Committee further decided to issue the Final Show Cause Notice for submission of compliance of adherence of conditions of NCTE Regulations, 2014 be issued to the institution under its new name. The withdrawal order issued as per the decision of SRC taken in the 401st meeting be treated as cancelled."
- 7. AND WHEREAS, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 20.09.2021. The institution has submitted a reply on 25.03.2022. the SRC in its 409^{th} Meeting held on $29^{TH}-30^{TH}$ March, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Anugraha B.Ed. College, Martin Luther School Campus, 208, 15th Main, Nagendra Block, Banashankari 3rd Stage, Girinagar, Bangalore, Karnataka-560050 for B.Ed. programme for 1 basic unit of 50 students".

8. NOW THEREFORE, this order is issued permitting the institution i.e., Anugraha B.Ed. College, Martin Luther School Campus, 208, 15th Main, Nagendra Block, Banashankari 3rd Stage, Girinagar, Bangalore, Karnataka-560050 run by Sri Venugopalaswamy Educational Trust, Bangalore, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at 10. the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the 11. Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
 - Sanctioned programme(s) along with annual intake in the institution:
 - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - Fee charged from students.
 - Available infrastructural facilities.
 - Facilities added during the last quarter.
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - The affidavit with enclosure submitted along with application. i.
 - The institution shall be free to post additional relevant information if it so
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and 12. display up-to-date information on its official website.



- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
