**CONTINUATION ORDER**

**WHEREAS**, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely **Shri Yedathore B.Ed. College, Arkanatha Road, 3<sup>rd</sup> Cross, K.R. Nagar, Mysore District-571602, Karnataka** vide order No. F.SRO/NCTE/B.Ed./2008-09/3635 dated 08.08.2008 for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 09.03.2015 for its willingness in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting **B.Ed. programme of two years duration with an annual intake of one basic unit of 50 students from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 315<sup>th</sup> meeting held on 17<sup>th</sup> – 18<sup>th</sup> June 2016 considered the matter and decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 27.06.2016. The institution has submitted reply on 18.07.2016.

4. **AND WHEREAS**, the SRC in its 318<sup>th</sup> meeting held on 08<sup>th</sup> – 09<sup>th</sup> August 2016 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a withdrawal order was issued to the institution on 26.10.2016.

5. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No. 89-784/2016 Appeal/5<sup>th</sup> Meeting-2017 dated 18.04.2017 confirmed the withdrawal order with effect from 2017.2018.

7. **AND WHEREAS**, the SRC in its 338<sup>th</sup> meeting held on 01<sup>st</sup> – 03<sup>rd</sup> May 2017 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a withdrawal order was issued to the institution on 05.05.2017.

8. **AND WHEREAS**, the institution had challenged the said withdrawal order dated 05.05.2017 issued by SRC, before the Hon'ble High Court of Karnataka Bengaluru and vide order 05.11.2020 passed in W.P. No. 10190/2020 and court has given direction, which is as under:-

***"In the above circumstances, this writ petition succeeds; a Writ of Certiorari issues quashing the impugned order; matter is remand back to the first respondent-NCTE for consideration afresh in accordance with law but ignoring Regulation 8(4)(1) of NCTE Regulation 2014 within eight weeks with retrospective effect.***

***The consideration of petitioner's claim for the grant of affiliation or such other privileges at the hands of second respondent-University shall be dependent upon the out come of the remand. It is hardly needs to be stated that the exercise to be undertaken in terms of this judgment shall be subject to out***

***come of the application said to have been filed by the first respondent-NCTE in the subject SLPs.***

***All other contentions of the parties are kept open.***

***Now no costs."***

**9. AND WHEREAS,** the SRC in its 409<sup>th</sup> Meeting held on 29<sup>th</sup> – 30<sup>th</sup> March, 2022 considered the matter and decided as follows: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Shri Yedathore B.Ed. College, Survey No. 26/1, Cheeranally Village, K.R. Nagar, Mysore District-571602, Karnataka for B.Ed. programme for 1 basic unit of 50 students."***

**10. NOW THEREFORE,** this order is issued permitting the institution i.e., **Shri Yedathore B.Ed. College, Survey No. 26/1, Cheeranally Village, K.R. Nagar, Mysore District-571602, Karnataka** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

**11.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

**12.** The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

**13.** The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and

non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
