WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, Carmel D.Ed. College, The Apostolic Carmel Educational Society, C/o Maria Nilaya, Near Shahapur Gate, Bidar, Karnataka-585403 run by The Apostolic Carmel Educational Society, Mangalore, Karnataka vide order no. F.SRC/NCTE/2009/D.Ed./RO/14191 dt. 26.06.2009 for conducting Elementary (D.Ed.) course with an annual intake of 50 students from the academic session 2009-2010.

2. AND WHEREAS, the institution has submitted written representation on 14.02.2022 for closure D.Ed. programme.

3. AND WHEREAS, the SRC in its 409th Meeting held on 29th – 30th March, 2022 considered the request and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide letter dated 14.02.2022 by withdrawing the recognition granted to Carmel D.Ed. College, The Apostolic Carmel Educational Society, C/o Maria Nilaya, Near Shahapur Gate, Bidar, Karnataka-585403 for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Carmel D.Ed. College, The Apostolic Carmel Educational Society, C/o Maria Nilaya, Near Shahapur Gate, Bidar, Karnataka-585403 for conducting D.Ed. programme of two years duration with an annual intake of 50 students with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training
