WHEREAS, recognition u/s14 of NCTE Act, 1993 was granted to the institution namely, Dhanlakshmi Srinivasan College of Education for Women, Thuraiyur Road, Perambalur, Pin-621212, TamilNadu for B.Ed.& B.Ed.-Al programme as per following details:-

- (i) The vide Order No.F.SRO/NCTE/B.Ed./2005-2006/4899 dated 23.12.2005 to offer Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.
- (ii) The vide order No.F.SRO/NCTE/2007-2008/11921 dated 25.09.2007 for conducting B.Ed. (Additional Intake) programme of one-year duration with an annual intake of 100 students.
- (iii) The vide order No.F.SRO/NCTE/B.Ed.-Al/2008/5094 dated 22.09.2008 for conducting B.Ed. (Additional Intake) programme of one-year duration with an annual intake of 100 students.
- 2. AND WHEREAS, the SRC in its 211<sup>th</sup> meeting held on 21<sup>st</sup> 23<sup>rd</sup> September 2011 has considered the matter and decided that shifting to new/permanent premises be permitted. Accordingly, as per the decision of SRC, an order was issued to the institution on 01.12.2011 for shifting to new premises.
- 3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 23.01.2015 and the revised provisional recognition order was issued on 23.03.2015, 08.05.2015 & 05.05.2015 to the institution for conducting B.Ed. programme (100 students), B.Ed. Additional intake (100 students) and B.Ed. Programme Additional Intake(100 students) of two years duration from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in 388<sup>th</sup> Meeting held on 14<sup>th</sup> & 15<sup>th</sup> September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a Show Cause was issued to the institution on 08.06.2021. The institution has submitted a reply on 06.07.2021.
- 5. AND WHEREAS, the SRC in its 401st meeting held on 11th 12th August 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 31.08.2021. The institution vide dated 30.12.2021 has submitted a written representation to the Final show Cause Notice.
- 6. AND WHEREAS, the SRC in its 411<sup>th</sup> Meeting held on 23<sup>rd</sup> 24<sup>th</sup> May 2022 considered the matter to close down the institution as requested by the institution and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993 Regulations Guidelines issued by NCTE from time to time and documents furnished by

the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide letter dated 30.12.2021 by withdrawing the recognition granted to **Dhanalakshmi Srinivasan College of Education, 227C, Thuraiyur Road, Perambalur-621212, Tamilnadu** for conducting **B.Ed. & anlongwith additional Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Dhanalakshmi Srinivasan College of Education, 227C, Thuraiyur Road, Perambalur-621212, Tamilnadu run by Dhanalakshmi Srinivasan Charitable & Educational Trust, Perambalur-621212, Tamilnadu for conducting B.Ed. Programme, B.Ed.-A.I. Programme and B.Ed.-A.I. Programme of two years duration with an annual intake of 100 +100+100 students (6 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
